Annual state reports to the Secretary are first due on October 7, 2001. Data from institutions with teacher preparation programs are due to states annually, beginning April 7, 2001, for use by states in preparing annual report cards to the Secretary.

1. BACKGROUND

In 2003-2004 year the teacher education programs at the University of Colorado at Boulder were nationally accredited by NCATE and re-approved by the Colorado Commission on Higher Education and the Colorado State Board of Education.

In the 2003-04 academic year, a total of 162 students completed teacher education programs at the University of Colorado at Boulder. Pass rate tables provided earlier in this report give details of the success of 137 of those program completers who took and passed the PLACE exam to fulfill their licensure exam requirement. The remaining 25 students took and passed the appropriate PRAXIS exam to fulfill their licensure exam requirement. We have created the following table (similar in format to the earlier PLACE table) to report the pass rates of our students on PRAXIS exams in 2003-04.
