Part III: Student Certification

As a basis for nondegree loan eligibility at the University of Colorado Boulder, I understand and agree to comply with the following terms:

- A. Title IV loan eligibility is limited to a maximum of **3 consecutive terms** (i.e. fall, spring, summer).
- B. Minimum enrollment required for nondegree financial aid is **6 hours** per semester.
- C. A student is ineligible for nondegree aid if concurrently admitted to a degree program at another institution.
- D. Each **semester** and **cumulative** GPA must be a minimum of **2.0**.
- E. You must complete 100% of all coursework you attempt each semester. You will not be eligible for future nondegree federal aid if you receive an **I, F, or W** for any coursework during a term. **Withdrawing** for the term will result in your financial aid being adjusted.
- F. Satisfactory completion of coursework taken as a Nondegree student does not guarantee admission into a degree program.
- G. Nondegree students applying to a graduate program may be limited in the number of transferable credits into graduate program.

I understand that financial aid I receive through this program is to be used for paying my Continuing Education bill. I further understand that if I exhaust my financial aid eligibility within the 3 consecutive term period, I am responsible for the remainder of my bill.
