POSTINGS: REPORTS, PRESENTATIONS, AND GRAY LITERATURE Recent reports and analysis have included work in 2013, 2014, and continuing in 2015 on the Colorado

State Water Plan, and discussions with committees of the Ditch and Reservoir Company Alliance, of Colorado, concerning policy issues in land conservation, water conservation and ditch company capacity to plan for the future.

Additional work involved participation in meetings and follow-up reporting from Rising Voices, and Rising Voices II; invitational meetings hosted by the National Center for Atmospheric Research for a group addressing climate change and climate impacts on Native Americans and Indigenous Peoples. A research proposal was developed by Wiener and others following Rising Voices, for a long-term approach to some issues in Native adaptation. The proposal awaits an independent institutional base, for reasons relating to copyright law and funding of institutions.

The website <www.colorado.edu/ibs/eb/wiener/> includes a wide variety of presentations and reports from the author, for different audiences and includes extensive documentation in "speaker's notes" sections of the powerpoint TM slides from most of the presentations. The website also includes "Re-Vision of a Western Irrigated Area..." 2011, available in present form; this is a lengthy report of a case study of the Bessemer Irrigation Ditch, east of Pueblo, CO, with discussion of the agricultural situation, the case study, the water transfers issues, and recommendations which are being modeled using the Water Evaluation and Planning (WEAP) tool, by research partner David Yates. This is a good representation of my aspirations to provide meaningful assistance for agriculture for what the National Research Council calls the transition toward sustainability.

Many presentations are also posted; the most comprehensive statement is the 2011 presentation to the Climate Prediction Applications Science Workshop, in Des Moines, IA, with special focus on agriculture; "Climate Information Applications for Resilience: Opening Wedge of Just Plain Sledge?" New materials are posted occasionally.

Other postings include an argument about property rights, short summaries of research findings, and the major part of the research applying a Decision Calendar for the Arkansas Valley for applications of improved weather and climate information, "Who wants to know what and when?" That extended field work and interaction with the agricultural and water community changed my research direction and interests.
