

2013-2014 Scholarship Application for Continuing Students

Please read the following instructions carefully:

Eligibility

To be eligible for scholarships, you must be enrolled as a law school student and maintain a minimum of 9 credit hours per semester, while receiving any scholarships. An exception to this rule is made for 3L students, who may take below 9 hours in their final semester. Joint degree students are eligible to receive scholarship money.

Scholarship Responsibilities

Scholarship recipients are required to do the following (or scholarship assistance may be withdrawn):

1. Send a thank you letter to your respective donor(s). Name and mailing address information will be provided with your scholarship offer letter. You must provide the Office of Admissions with a copy of your thank you letter, either by hand or by email to lawadmin@colorado.edu.
2. You must attend the Scholarship Recognition Reception that will be held on Thursday, September 26, 2013 (location TBA).

Application Process

- **Deadline: 5:00 pm, Wednesday, May 15, 2013**
- To apply for scholarships, please submit items #1-4 to the Office of Admissions and complete item #5 online:
 1. A signed, dated, and completed application form
 2. Resume
 3. Unofficial transcript (print from My CU)
 4. Essays or Lists as required for any Special Interest Scholarships for which you would like to be considered (see the Special Interest Scholarships information). For Essays and Lists, the following criteria apply:
 - Essays should be typed, double-spaced, 1-2 pages only.
 - Lists should also be typed, double-spaced, not to exceed 1 page.
 - Put your name and the name of the scholarship at the top of each page.
 - **NOTE:** be sure that the contents of the Essay or List are appropriate for the particular scholarship or group of scholarships.
 5. Complete the FAFSA online at <http://fafsa.ed.gov>, which is necessary to be considered for any scholarships that have need as a component.

IMPORTANT: Applications will NOT be accepted after 5pm on Wednesday, May 15, 2013.

Scholarship Categories and Instructions

- Scholarship awards vary greatly in amount, from hundreds to thousands of dollars. Awards generally fall into two categories: **Merit Scholarships** (which are based on academic achievement, and some of which also require financial need); and **Special Interest Scholarships** (which consider a variety of factors, as discussed further below).
- To be considered for the **Merit Scholarships** that are based solely on academic achievement, you need only submit an application, resume, and transcript. However, to maximize your chances of receiving a Merit Scholarship, we encourage you also to submit a FAFSA online. Submitting a FAFSA is required for you to be considered for Merit Scholarships that require financial need.

- **Special Interest Scholarships** require either an essay or a list, and many require filing of the FAFSA, as described above, if financial need is a factor for consideration. Please list scholarships from this category for which you want to be considered on the lines provided on the scholarship application form. To be considered for Special Interest Scholarships, you must submit the application, resume, transcript, and an essay or list as described.

Scholarship Decisions and Notification

- Incomplete applications will not be considered for awards.
- Applicants will be notified of the committee's scholarship decisions in August. Decisions will be sent by email only to the email address you provided on your application. You will be notified if you are not selected to receive any scholarship money. No letters will be mailed.
- While we would like to provide scholarship assistance to every applicant, funding constraints prevent us from doing so.

Special Interest Scholarships

Special Interest Scholarships support students who demonstrate a variety of different strengths and interests. To award these scholarships, we need additional information, as described herein. Each scholarship has a notation that it requires either:

- (1) An essay that addresses the requirements and is one page or less, double-spaced (“Essay”); or
- (2) A list of activities that demonstrate your commitment to the relevant factors for the scholarship, as well as any additional information that you want the Financial Aid Committee to consider (“List”). For example, a List could include (this example relates to the Judi Wolf Scholarship):
 - Member, Women’s Law Caucus
 - Volunteered for women’s shelter, 2008-2010
 - Starred in 2012 Law School Musical
 - Studied ballet for 15 years
 - Student Attorney, Family Law Clinic, 2012

Please put your name and the name of the scholarship(s) or group at the top of each page you submit.

Many of the Special Interest Scholarships require financial need, so we encourage all applicants to complete the FAFSA online.

You can apply for as many scholarships as you would like.

AMERICAN INDIAN LAW SCHOLARSHIPS

To apply for these scholarships, you must submit either an Essay or a List, as indicated below.

- **Frank E. (Sam) Maynes Scholarship - Essay**
 - The Maynes Scholarship, established by the Durango firm of Maynes Bradford Shipp & Sheftel LLP, is a need-based scholarship awarded to a Colorado Law student with an interest in American Indian Law or water law.
- **Getches American Indian Scholarship - List**
 - Established in 2011 in memory of David Getches and in honor of his significant contributions to American Indian law, and in memory of his commitment and service to the law school as dean from 2003-2011, is awarded to students committed the study of American Indian Law, as demonstrated through coursework and other relevant activities.

BUSINESS LAW SCHOLARSHIPS

To apply for these scholarships, you must submit either an Essay or a List (separate Essay or List for each one), as indicated below.

- **Association of Corporate Counsel Corporate Transactions Scholarship – Essay**
 - The Association of Corporate Counsel Scholarship, established by the Colorado Chapter of the organization in 2010, is awarded to one second or third year student interested in transactional legal work, particularly with emerging, entrepreneurially oriented companies. A resume and essay outlining related student background must be submitted for review.
- **Entrepreneurial Law Clinic Scholarship – Essay**
 - The Entrepreneurial Law Clinic (“ELC”) alumni established the Entrepreneurial Law Clinic Scholarship to recognize and reward annually a Colorado Law student interested in entrepreneurship and transactional law. This scholarship is awarded to the student who best exemplifies the ELC’s mission: to develop attorneys with a spirit of community service, a commitment to understanding start-ups and new businesses, and an eagerness to be involved in the CU/Boulder/Denver area’s entrepreneurial ecosystem. Applicants must submit a copy of their application to participate in the following year’s ELC (fall and spring semesters) along with an essay addressing, at a minimum, the following criteria:
 - Demonstrated interest in entrepreneurship and transactional law (as indicated through law course selection, work experience, or other involvements);
 - Dedication to community service evidenced by contributions to the entrepreneurial community outside of the classroom; and
 - Any special hardship or circumstances which make the applicant particularly deserving of the scholarship.
- **The Buck Family Law Scholarship – List**
 - Awarded to one or more second or third year students who are interested in doing in-house transactional work, particularly in the energy industry.
- **The Yaley Family Law Scholarship - Essay**
 - Awarded to one or more second- or third-year law students who demonstrate academic excellence and are interested in pursuing an in-house legal career, particularly with respect to transactional and international legal matters.

CRIMINAL DEFENSE SCHOLARSHIPS

To apply for these scholarships, you must submit a separate Essay for each one.

- **Melanie Ruth Vogl Memorial Scholarships - Essay**
 - This scholarship was established by a gift from her estate to be awarded to students who have demonstrated outstanding trial advocacy skills and who desire to practice public interest law in the office of a public defender.
- **Bryan Shaha Scholarship - Essay**
 - Awarded annually to one or more deserving students who have indicated a desire to work in indigent defense services upon graduation from the Law School. Indications may include, but are not limited to, participating or having

participated in the clinical program, interning for the state public defender or other indigent defense services provider, and intending to work for the Colorado Office of the Public Defender or other indigent services provider upon graduation.

- **Dan Barash Scholarship – Essay**

- The Dan Barash Scholarship was established in memory of Dan Barash ('02) by his parents, Norma and Paul G. Barash. Dan participated in both the Criminal Clinic of the Legal Aid & Defender Program and the Wrongful Convictions Clinic. After graduation he worked for the Office of the Public Defender for the State of Colorado, working in the El Paso County office during his short career. Dan passed away in 2004 from complications following surgery to relieve symptoms of Crohn's disease.
- The scholarship will be awarded to a student who has demonstrated interest in criminal defense work through current or past enrollment in a criminal clinic, participation in a Public Defender Office internship or externship or related work before or during law school, and/or intention to work for the Colorado Office of the Public Defender or another indigent defense services provider.
- A resume and essay are required. The essay should include a discussion of the applicant's career goals and explain how these goals relate to Dan's commitment to public service. Selection of recipients each year is made in consultation with Dan's brothers, Dave and Jed.
- Prior to applying, potential applicants should talk with Dan's teacher and friend, Professor Pat Furman (furman@colorado.edu), or Professor Ann England (ann.england@colorado.edu), or Professor Violeta Chapin (violeta.chapin@colorado.edu or) to receive further background on this scholarship.

ENVIRONMENTAL & NATURAL RESOURCES SCHOLARSHIPS

To apply for these scholarships, you must submit either an Essay or a List (separate Essay or List for each one), as indicated below.

- **Berg Hill Greenleaf & Ruscitti LLP Scholarship – List**

- Awarded to a second or third year student who demonstrates academic excellence, and has an interest in practicing in the areas of litigation, water law, and environmental law.

- **Gordon and Welda Allott Scholarship – Essay**

- An annual award to a second or third year student who demonstrates a strong interest in natural resources law. The fund was established by the late Senator and Mrs. Allott as part of their long-standing interest in the development and conservation of natural resources. *This is a special program for a student who wishes to do legal research under the supervision of a faculty member on various projects connected with the Getches – Wilkinson Center for Natural Resources, Energy, and the Environment for one semester or for the entire academic year.* Applicants for this award must demonstrate financial need. Academic performance may be considered in making the award, but will not be the sole criterion.

- **Frances Green Sustainability Scholarship – List**
 - This scholarship is for a second or third year student who has demonstrated a commitment to working for sustainability and/or the problem of reversing climate change. The recipient commits to spending 50 hours of volunteer work at an environmental organization or advocacy group pursuant to the Public Service Pledge.
- **Tom Lustig Environmental Scholarship – Essay**
 - This scholarship, established in 2010 by Paula Connelly ('76) in memory of her husband Tom ('74), is awarded to one or more students interested in pursuing a career in public interest environmental law. Preference may be given to those who have participated in or are participating in the Natural Resources Clinic.
- **Sustainable Development Law Scholarship – Essay**
 - Open to any law student who has demonstrated an interest in the area of real estate development and/or land use planning. The applicant should demonstrate respect for the environment and seek to foster a spirit of collaboration between the real estate development community and environmentalists. The student must be pro-responsible development, and should show high academic performance **in the relevant area**. An essay of no more than one double-spaced page addressing the student's interest in and activities related to sustainable development, including any relevant extracurricular, academic, and professional activities, should be submitted.
- **The Charles N. Woodruff Fellowship – Essay**
 - Established by the Boulder law firm of Moses, Wittemyer, Harrison and Woodruff, P.C., in memory of Charles Woodruff ('67). Mr. Woodruff grew up in Walden, Colorado, and became a highly successful water resources lawyer. This fellowship promotes excellence in the practice of natural resources law and is awarded to a student from rural Colorado who demonstrates academic excellence and *functions as an intern in the Getches – Wilkinson Center for Natural Resources, Energy, and the Environment*.
- **John & Cynthia Schultz Law Scholarship – Essay**
 - This scholarship was established by John Schultz ('53) and his wife Cynthia in 2004, and is awarded to second or third year students based on financial need, high academic achievement and a strong interest in natural resources, oil and gas, energy, or Constitutional law.

INTELLECTUAL PROPERTY SCHOLARSHIPS

- **Thomas E. Schatzel Intellectual Property Scholarship**
- **James R. McBride Scholarship**

To apply for this group of scholarships, you must submit a List demonstrating:

- Interest in pursuing a career in intellectual property law, including career goals
- Related academic and/or work experience
- Reasons for deserving an intellectual property scholarship

PUBLIC INTEREST SCHOLARSHIPS

- **The Davis Graham & Stubbs Scholarship**
- **Gene R. Nichol Public Interest Scholarship**
- **Kenneth N. Kripke and Derril K. Kripke Scholarship**

To apply for this group of scholarships, you must submit a List demonstrating:

- Commitment to improvement of the legal profession and enlargement of its contributions to the public interest
- Demonstrated work (**past proven commitments over future assertions**) in the public sector delivering legal services to people who could not afford it (e.g., on behalf of the Legal Defense Fund or other programs)
- Interest in pursuing a career in trial law

TAX, ESTATE, AND ELDER LAW SCHOLARSHIPS

To apply for these scholarships, you must submit either an Essay or a List (separate Essay or List for each one), as indicated below.

- **The William J. Bowe Scholarships – List**
 - Awarded to students who show good scholastic ability in law school, have financial need, and demonstrate an interest in practicing in estate planning and taxation. The fund was established by fellow faculty members and friends of the late Professor Emeritus William J. Bowe.
- **Colorado Bar Association Tax Section Scholarship – Essay**
 - The Tax Section of the Colorado Bar Association is offering a scholarship to a student with high achievement in law school taxation courses and an interest in practicing law with an emphasis in taxation matters.
- **Chayet & Danzo, LLC, Colorado Elder Law Scholarship – Essay**
 - This scholarship was established by Marco Chayet ('97) and Frank Danzo ('95) of the Denver firm in 2010, is awarded to one or more students interested in pursuing a career in the area of elder law and/or probate and estates to assist the elderly, disabled and incapacitated and their families in times of need. This can be demonstrated by their choices of coursework (estates, probate, trusts, estate planning, or wills & trusts), legal aid clinics and externships. Preference for a 2L or 3L based on merit and student participation in mock/moot court competitions, writing competitions, and trial advocacy in elder law, estates, probate, trusts, etc.

CHARACTER AND PERSONAL EXCELLENCE SCHOLARSHIPS

To apply for any of these scholarships, you must submit a separate Essay for each one.

- **David Sutcliffe Memorial Scholarship - Essay**
 - A scholarship to a second-year student with financial need, who most represents David's love of life. Applicants shall write an essay about all or one of the following topics: extracurricular activities, unusual effort made in attempt to get into law school, and/or how you would be described by classmates and peers.

- **Rodney Lewis Scholarship – Essay**
 - Established by the Class of 2004, this scholarship is awarded to one second- or third-year law student who exhibits Rodney’s qualities of a desire for learning, a love of life, and a dedication to one’s community (law school or other community). Preference is given to an applicant committed to using his or her law degree in the field of education. Financial need may be considered.
- **William C. McClearn Scholarship - Essay**
 - Awarded each year to one student who reflects his values. Special consideration is given to those with demonstrated strength of character, high integrity, intellectual ability, academic excellence, and commitment to community service.
- **J. J. Witt Memorial Law Scholarship - Essay**
 - This scholarship was established by the Class of 2001, to be awarded to a student who best exhibits qualities like J. J. These qualities include a positive outlook, a cheerful disposition, a sense of humor, and a sincere desire to see his or her peers and colleagues benefit as much as possible from their own pursuit of the Juris Doctor. Financial need may be considered.
- **Gary Woods Family Scholarship - Essay**
 - The Gary Woods Family Scholarship, established in 2010 by Sandra Woods and family in memory of her husband Gary A. Woods ('70), is awarded to one second or third year student who exhibits Gary’s balance in life: academic purpose and broad life interests and experience (including athletics and community activities).
- **Class of 2008 Jennifer Lee Shelton Scholarship - Essay**
 - Jenn Shelton was a cherished member of the Class of 2008 at the University of Colorado Law School who unexpectedly passed away as a 3L. The Class of 2008, the Shelton family, and Jenn’s friends honor her memory with this scholarship, which is to be given to one or more third-year law students who embody Jenn’s spirit of untiring love of life. Tremendously well-rounded, Jenn exhibited strong leadership skills in all endeavors, never took herself too seriously, and maintained many interests outside of law school. She placed great value on friendship — always demonstrating strong loyalty and treating others with love and respect while expecting the same in return. She also balanced self-confidence with a strong sense of humor.
 - In addition to the required criteria listed above, secondary factors to be considered may include the following: an interest in international experiences, appreciation of the outdoors, love for animals, athletic prowess, and an uncanny ability to find optimism and fun wherever one goes and in whatever one does. Through academic achievement is a contributing factor, it is not a deciding factor. Furthermore, applicants who demonstrate how these attributes have helped them overcome some sort of personal adversity will be favored. Please submit a piece of creative writing, not limited to an essay, demonstrating one or more of these traits. Limit of 500 words.
- **Clifford J. Calhoun Scholarship - Essay**
 - An award to a second- or third-year law student who demonstrates academic excellence and the characteristics of Professor Emeritus Clifford J. Calhoun: intellectual ability of a high order with a commitment to enhance the classroom experience for all of his or her fellow students and prodigious integrity with an

absence of self-aggrandizement. A short essay describing your qualifications, career aspirations, and *a letter of recommendation from a faculty member* must be submitted with this application.

- **Earnest-Johnson/Christian Legal Society Scholarship - Essay**
 - An award to a student who demonstrates a commitment to the principles and values that Hillary Earnest Johnson exemplifies: strong academic skills and a demonstrated commitment to a virtuous lifestyle and professional excellence.
- **Virginia "Ginny" E. (Shapiro) McCrae Scholarship - Essay**
 - An award to a third-year student who displays original and insightful intellectual abilities, diverse personal interests and an untiring love of life. Ginny McCrae was a 1986 graduate of the law school. She was an attorney for the Resolution Trust Corporation in Denver. Donations for the scholarship are from her family and friends.
- **Victor Quinn Scholarship - Essay**
 - A scholarship to one or more students with financial need. A short essay describing an ethical issue you confronted and how you resolved it must be submitted with your application. The ethical issue need not be limited to a legal issue.

COMMITMENT TO DIVERSITY SCHOLARSHIPS

To apply for these scholarships, you must submit either an Essay or a List, as indicated below.

- **Commitment to Diversity Group - Essay**

The following scholarships are primarily awarded to students who have strong academic achievement, and have contributed to a diverse student body. Need is a factor for these scholarships. Please explain your qualifications in your essay. *Only one essay is required to apply for all of the scholarships in the list below.*

Note that each of the following scholarships requires a separate List (one List per scholarship).

- **CHBA Louise Romero Memorial Scholarship - List**
 - This scholarship will be awarded to a student in good standing, who demonstrates financial need, and has made or is committed to make significant contributions to the Hispanic or Latino community in Colorado.
- **William E. & Maxine Rentfro Law Scholarship - List**
 - To assist in the achievement of a diverse student body by providing a need-based scholarship to a student committed to protecting and preserving human and civil rights and to improving the lot of those seeking full participation in the American dream: racial minorities, immigrants, laborers, and others.

- **Class of 1994 Seumsap Ly Memorial Scholarship - List**
 - A scholarship in memory of Seumsap Ly '94, awarded to a deserving student who demonstrates a concern for Hmong or Asian issues and who has demonstrated service in the Asian community.
- **Gordon G. Greiner Endowed Scholarship - List**
 - This scholarship goes to a second or third- year law student with financial need, an interest in Constitutional Law, and who promotes the University's policy to achieve a diverse student body.
- **The Ted Woods Memorial Scholarship - List**
 - This scholarship was created by friends and colleagues in memory of Theodore E. Woods, and is awarded to a student who has contributed to a diverse student body, and who was distinguished both academically and athletically while an undergraduate at the University of Colorado.

COMMUNITY-CENTERED SCHOLARSHIPS

To apply for these scholarships, you must submit either an Essay or a List (separate Essay or List for each one), as indicated below.

- **Colorado Women's Bar Association Foundation Jennifer Robbins Scholarship - List**
 - One scholarship to a second year and one to a third-year student who are members and active participants in the CWBA and who demonstrate financial need.
- **Aurora Bar Association Scholarship - Essay**
 - The Aurora Bar Association Scholarship is awarded to one second or third year student who is a resident of Aurora, plans to pursue a legal career in Aurora, or demonstrates another strong tie to the City of Aurora. Financial need may be considered.
- **The Jean S. Breitenstein Law Clerks Scholarship - Essay**
 - One award to a third-year student without regard to residency who demonstrates academic ability and achievement, has financial need, and *expresses a desire to enter the private practice of law in Colorado*. The fund from which the award is made was established by former law clerks of the late Judge Breitenstein of the Tenth Circuit Court of Appeals. Selected finalists have a telephone interview with the Financial Aid Committee.
- **Moses Lasky Scholarships - List**
 - Awards will be made to outstanding students who will make significant contributions to the legal profession, either as lawyers or teachers, and who also have financial need. This fund was established by Moses Lasky, class of 1928.

SERVICE SCHOLARSHIPS

- **The Law Alumni Scholarship**
- **Ann Getches Scholarship**

To apply for this group of scholarships, you must submit a List demonstrating service to the law school community.

SPECIAL CIRCUMSTANCES SCHOLARSHIPS

To apply for each of these scholarships, you must submit a List (separate list for each).

- **Donald S. Stubbs Scholarships - List**
 - Awarded to students who are children of families whose principal occupation or employment is the operation of a ranch or farm or who are otherwise closely related to the farming or ranching industry in **Colorado**. Approximately equal consideration will be given to a student's financial need, past and potential academic achievements, and promise as a practicing community lawyer. The fund from which the awards are made was established in honor of Donald S. Stubbs, a 1932 graduate who is a founding partner in the Denver law firm of Davis, Graham & Stubbs.
- **Robert M. Gilbert Law Scholarship - List**
 - An award to a non-traditional student, particularly one who exceeds 30 years of age who may also be a single parent or individual in life transition such as a career change, divorce or widowhood; to assist an individual who is trying to better their life by attending law school, and needs financial assistance in order to achieve this goal.
- **Thomas and Claire Brown Scholarship - List**
 - A scholarship to assist a student who has returned to law school with children and is therefore in a position where his or her employment opportunities (or opportunities of the spouse) are substantially restricted.
- **Judi Wolf Scholarship - List**
 - Awarded to one or more third year law students. Special consideration is given to students with demonstrated commitment to using their legal education for advocacy and representation on behalf of women and issues impacting the lives of women. An interest in the performing arts will also be given special consideration. Financial need will be considered but is not determinative.
- **Shawn Stigler and Alex Nelson Alpine Endeavors Law Scholarship - List**
 - Established in 2004, this scholarship will be awarded to a third year student who in his or her first two years of law school demonstrated a passion for the alpine sports (skiing, snowboarding, telemarking, etc.). Submit a list illustrating your pursuit of excellence in and love for the alpine sports in spite of the rigors of the legal curricula.
- **Military Service Scholarship – List**
 - A scholarship to assist a student who has served the country through military or similar service.
- **Trailblazer Scholarship – List**
 - A scholarship to assist a student who is in the first generation in his/her family to earn an undergraduate degree.

This list of scholarships is not an exhaustive list; other scholarships will be awarded based on application materials only. This list and the descriptions of the criteria are subject to change at any time and without notice. While we expect to be able to award all listed scholarships, it is possible that funding or other constraints will impact availability.
