The move of the Florida regional collection to off-side storage

There was a question about contingency plans if a significant portion of a collection is moved offsite. Chris Brown offered to send DU's plan that was submitted to the GPO when their collection moved. Chris noted that there have been more answers to the questions about Florida and that "GPO is pleased with the dialog".

The following concerns were addressed: collection expertise, reference services, retroactive cataloguing, finding-aid locations, selective library needs and offers, turn-around rates for materials (Florida is at 24 hours, DU is at 2-4 hours).

Recommendation:

Hein Online/Privacy Act

Mark Popielarski was contacted by Hein Online about scanning 8 volumes related to a privacy act from the 1970s-1990s. He was given two options: 1) cut the binding, scan, and return the destroyed copy or 2) try to do the scan with cutting. Peggy recommended that they avoid the destructive scanning option. This appears to be a common text, though Hein Online suggested otherwise.

Indexes for the Federal Register and CFR

Erik Beck discussed a new bill (HB 4195) that has been introduced to the House of Representatives. This bill would revise the language in the federal code by amending Chapter 15 of Title 44 where it discusses how the Federal Register is printed. They want to change the language to say "Publish" rather than "Print" (presumably so that they can stop printing paper copies).

The American Association of Law Libraries is asking for anecdotes and examples of instances where the print edition, in particular, was useful for patrons and librarians. A number of participants shared stories and noted that the index, in particular, is crucial.

Discussion: Serial Set ProQuest vs. Readex

Readex has better bibliographic records and is more complete.

ProQuest integrates well with other ProQuest products and the PDF's are downloadable and smart (so you can seek and find relevant terms).

Chris uses Readex to find it and ProQuest to manipulate and use it.

Additionally, the Serial Set Maps are much better through Readex.

Demo: Eastview's World News Connection and Readex's JPRS

Background:

FBIS was started by the OSS and was focused on transcribing international radio broadcasts. It evolved and began providing news from a variety of resources. Readex has the daily reports from 41'-96'. Most recently, as World News Connection, it was available through ProQuest. However, on December 31, 2013 NTIS and the CIA sunsetted World News Connection and NTIS ordered ProQuest to stop offering World News Connection. There is a new vendor, Eastview Press, and it covers 1996-2013. Chris demonstrated this new interface.

JPRS is the Joint Publications Research Service Database (available from Readex)

JPRS is like a sister publication to FBIS:

FBIS was created to meet the need of translating foreign broadcasts

JPRS was created to meet the need of translating foreign scholarly publications.

The JPRS Series covers many different topics and has a date range from 1957-1995.

Library significant events

- **CU Boulder:** in conjunction with the law school, CU Boulder was able to buy the second piece of Legislative Insight, the entire Serial Set, Executive Branch Documents, Bills and Laws, and legislative histories. The also agreed to a deal through CRL to acquire World News Connection through Eastview Press.
- **CU Law:** Also mentioned the ProQuest Congressional package.
- **Colorado State Library:** No major updates
- **Western State:** No major update

- **UCCS:** Two new positions were filled and they start in July (web development and library instruction). This is UCCS's 40th year anniversary as a depository library and they are planning some sort of display.
- **Adams State:** New instruction librarian, no more major updates
- **DU:** There is an open cataloging position
- **DU Law:** No major updates
- **UNC:** He is continuing to weed the tangible collections (a process made easier when weeding the sections that CU has cataloged)
- **School of Mines:** They have signed a letter of agreement with GPO for cataloging 4 USGS series (to make electronic records for OCLC and GPO. They will PURL everything and distribute to the CGP).
- **CU Boulder Cataloguing:** Tassanee is waiting on a letter of agreement from GPO for a similar project
- **Colorado College:** They are going through a library remodel. With less space available for shelving, they might start thinking about remote storage.
