Leadership Framework

My leadership is oriented toward achieving meaningful outcomes that positively impact students, faculty, the campus community, partner units and programs, and the broader public. I pursue these outcomes by emphasizing fairness in decision-making processes, communication, relationships, and participation - treating the library as a shared enterprise rather than a hierarchy of roles. This approach is grounded in evidence-based decision making and strategic alignment, drawing on assessment, comparative analysis, and stakeholder input to set priorities, allocate resources, and evaluate impact. My leadership is intentionally outward-facing, shaping how libraries engage campus constituencies, community partners, and donors in ethical, equitable, and accountable ways. As a dean, I represent the library in campus-wide leadership forums, advocating for the library's strategic contributions to teaching and learning, research and creative activity, student success and resilience, institutional sustainability, and public engagement. Across these contexts, I embed principles of procedural, distributive, informational, interactional, and contributive justice into the everyday work of libraries, ensuring that values and institutional priorities are translated into coherent, visible action rather than remaining aspirational.

A core element is team engagement and participatory leadership. I established library-wide monthly meetings for staff and faculty that prioritize broad participation, transparent communication, and recognition of individual and collective accomplishments. I foster an open-door culture and consensus-oriented decision-making grounded in collective expertise, cultivating trust and psychological safety so employees can question assumptions, raise concerns, and offer dissenting perspectives. When consensus is not possible, I ensure clear, candid, and timely communication about the rationale, constraints, and institutional context shaping leadership decisions, both within the library and in my role as an academic dean accountable to campus leadership. In my direct supervision of faculty and staff, I lead with a collaborative, trust-based approach that is respectful of professional expertise while remaining actively engaged and supportive. I empower individuals to exercise their authority and encourage diverse management styles, while maintaining clear expectations and communication. My goal is not to centralize control, but to cultivate confidence, judgment, and leadership capacity across the organization.

Organizationally, I have created, led, and sustained comprehensive programs advancing inclusion and equity, including governance structures, strategic directions, and accountability mechanisms that translate values into action across services, collections, and spaces. I have led successive workplace climate and culture assessments, collaboratively synthesizing findings and championing organizational change initiatives to address inequities, strengthen trust, and improve effectiveness. Justice principles are embedded into recruitment, mentoring, and professional development to ensure equitable access to leadership opportunities and meaningful participation across staff and faculty roles. These result in inclusive and accessible library spaces, collections, and services.

Finally, I extend this leadership through national service, professional dialogue, and scholarship, contributing to field-wide standards, leadership practices, and the advancement of liberatory librarianship, a conceptual term I co-developed. Liberatory librarianship is the intentional use of library expertise, systems, and resources to challenge inequities embedded in information ecosystems – including access, discovery, representation, and preservation while broadening participation in knowledge creation and stewardship. This model supports communities and individuals not traditionally centered as stakeholders in higher education through partnerships.

- Created a donor-funded Collaboration Commons supporting a new model of professor-led instruction in the library advancing course-based research, librarian-led academic skill-building programs (e.g., *Bite-Size Study Nights* and *Be an Empowered Researcher*), and growing student group-organized participation in open learning opportunities.
- Advanced the Center for Student Innovation (CSI), in collaboration with the Faculty Development and Innovation Center, as a socio-technical hub supporting student skill exploration while partnering with faculty to enable innovation in teaching, research, experiential learning, and digital scholarship.
- Led donor-funded planning and space redesign to relocate the Writing Center to the library (Summer 2026), integrating librarian research support with writing counseling to provide coordinated, end-to-end support across the research lifecycle.
- Launched and expanded Authors@EIU, including faculty and alumni authors, as a signature scholarly and public-engagement series.
- Conceived and co-developed, with the Dean of Student Success, the First-Gen Hub, including development of the concept and funding proposal, resulting in a new, funded student success unit reporting to Student Success.
- Developed a Maslow-inspired hierarchical model for information literacy, in partnership with the Student Success Librarian, as a planning and communication framework for aligning library instruction with faculty priorities and student success goals.

- Advanced the Booth Library Ambassadors Program as a student-led engagement and leadership initiative, positioning students as partners in outreach, communications, programming, and peer-to-peer advocacy while strengthening the library's visibility and role in student success.
- Led comprehensive and participative marketing and communications planning, revitalizing social media, *NoteBooth*, the Annual Report, and public-facing messaging.
- Revived a library fundraising and advancement program focused on strategic communications, donor engagement, pipeline development, endowment stewardship, and preparation for a future capital campaign.
- Established a Friends of Booth Library group focused on fundraising, advocacy, and engagement with alumni and regional stakeholders (launch ongoing).
- Conceived and launched, through donor engagement, the Dr. Hassan and Zahida Shakir Islamic Perspectives Initiative, including creation of a special collection and an annual visiting scholar program with campus and community lectures, exhibits, and events.
- Strengthened partnerships between University Archives and Alumni Affairs, enhancing institutional memory and alumni engagement.

Provided senior leadership for a flagship, land-grant academic and research library system of approximately 400 employees across multiple campuses, encompassing 13 buildings and more than 500,000 square feet. Managed a \$40M operating budget and led strategic planning, organizational redesign, shared governance, large-scale facilities projects, workforce transformation, and national and international digital infrastructure initiatives. During a period in which the University of Florida advanced in national rankings and significantly expanded its research enterprise, helped guide the Libraries' adaptation to support increased research activity, interdisciplinary scholarship, graduate education, and evolving faculty and student needs. Represented the Libraries in campus, national, and international forums. Advanced through successive library faculty ranks while simultaneously holding senior administrative appointments with institution-wide responsibility.

- Led the development and execution of library-wide Strategic Directions, translating institutional priorities into actionable goals that guided budgeting, staffing, space planning, and programmatic innovation across the library system.
- Led multiple library-wide reorganizations grounded in organizational change management and shared governance, including integration of the Health Science Center Libraries, establishment of a new tenure-home department structure, and creation of new functional units aligned with evolving research and teaching needs.
- Established and sustained a formal shared governance model in a unionized faculty environment, including annual goal-setting, transparent prioritization, and participatory decision-making tied to budget development.
- Strengthened coordination and strategic collaboration between the main library system and the Law Library, improving alignment in planning, professional development, and governance practices while respecting the Law Library's reporting relationship to the College of Law.
- Served as founding Chair of Technical and Support Services, establishing a new tenure-home department integrating traditional technical services and emerging functional expert roles (e.g., scholarly communication, assessment, data management, and AI-machine learning); drafted departmental by-laws, established cross-unit shared governance, and developed tenure and promotion standards to support equitable faculty career progression.
- Led the Libraries' transition to and long-term success under Responsibility Centered Management (RCM), developing financial models, comparative peer analyses, and institutional narratives that supported sustained and increased funding.
- Secured \$3.2M in increased recurring institutional funding for collections through data-driven advocacy, while also planning for and mitigating multiple rounds of budget reductions (10%, 7%, and 2%) with minimal long-term harm to institutional capacity.
- Developed transparent financial reporting and assessment practices, including monthly budget dashboards, peer benchmarking methods, and analytics used by campus leadership and adopted as models by other institutions.
- Led 12 minor and 15 major renovation projects, including full branch library renovations; re-envisioned collaboration, instructional, and digital scholarship spaces; library and museum exhibit environments; makerspaces and studios; and integration of two Starbucks café locations within library facilities.
- Secured over \$11M in deferred maintenance and infrastructure funding, and advanced user-centered space improvements supporting accessibility, inclusion, and wellbeing, including the first campus lactation rooms, expanded accessible restrooms, and a prayer room.
- Collaboratively re-architected the library workforce with library faculty, staff, and campus partners to align with emerging research, teaching, and student success needs, creating new functional roles and career pathways (e.g., digital scholarship, data services, scholarly communication, AI, publishing, student success).

- Designed, implemented, and sustained, through shared governance processes, equitable classification, promotion, and compensation structures to support recruitment, retention, career progressions, and organizational agility.
- Conceptualized and, in partnership with the Senior Associate Dean, launched Academic Research Consulting & Services (ARCS), positioning the library as an active research partner through cross-disciplinary consultation and training in research methods, data management, data analysis/visualization, publishing, and research impact across the research lifecycle.
- In partnership with the Chair of Digital Partnerships and Strategies established the LibraryPress@UF, strengthening library-based publishing, open access infrastructure, and partnerships with the University Press and faculty authors.
- Led digitization at scale and development of shared digital collections, including creation of the Libraries' first Digital Preservation Plan and advancement of shared print, demand-driven acquisitions, and transformative open access agreements at state and regional levels.
- Created and led a comprehensive and broadly participative DEI program, including governance structures, strategic priorities, curriculum development, successive workplace climate assessments, equitable classification and salary systems, and creation and supervision of a DEI Librarian faculty position.
- Established and led an internal library grants and assessment ecosystem, including strategic opportunity grants, assessment frameworks, and consultative support that enabled faculty and staff to pilot innovations, scale successful programs, and align local initiatives with institutional and consortial priorities.
- Initiated and led the creation of a comprehensive professional development and recognition ecosystem, including mentoring programs, tenure and promotion support, leadership development, employee recognition awards, and an internal grants program.
