- I. <u>Address to Assembly</u> Todd Saliman, CU President The BFA welcomed CU President Todd Saliman to the first assembly meeting of the year. The BFA Executive Committee had sent a list of discussion items the previous
  - week which included:
    - State funding and ballot measures the final compromise on recent legislative bills on property taxes was supported by CU but will still have a major financial impact on higher ed over the next ten years.
    - Diversity at state and university level no concerns about state or Regent changes to DEI commitments in Colorado. Also, emphasized that great work is happening on the Boulder campus.
    - Climate crisis steps at System level Updates to older buildings on campus are impeded by funding issues, but Saliman is very pleased with Chancellor Schwartz's addition of a V.C. for Sustainability. Saliman also noted several system areas that are tracked in <u>strategic plan metrics</u> and <u>2023 sustainability</u> <u>report</u>.
    - Free Speech CU protects the right to free speech, but also follows campus rules that might come into play, such as the camping ban at Auraria last year. Regent policy reiterated who has the right to speak on behalf of the university last spring.
- II. <u>Administrator Appraisal Report V.Provost & AVC Faculty Affairs, Michele Moses</u> Deb Cantrell, chair of the BFA administrator appraisal committee reviewed last spring's report on Michele Moses. Ratings for Moses were among the highest the committee had seen. Moses also committed to more engagement with BFA from her office. Details can be found on the report in the shared folder.

- VI. <u>BFA Elections</u> Internal elections concluded September 5<sup>th</sup> and External elections begin September 9. All campus faculty senate members are eligible to nominate themselves and serve on a BFA standing committee. Additionally, there are Boulder seats open on Faculty Council committees. BFA members vote on nominees during external elections via Qualtrics on September 19 & 20.
- VII. <u>CU Faculty Council Updates</u> Alastair Norcross, CU Faculty Council Chair & BFA Vice Chair
  - All university faculty will receive an email asking them to *vote on the system faculty constitution* which is being updated to reflect new titles (teaching professors, etc.) as well as a change in officer roles (chair-elect; chair; immediate past chair). Please encourage your constituents to vote to approve.
  - Norcross attends Board of Regent meetings and will be speaking at the September 12-13 meeting. He asked representatives to provide feedback to a *proposed amendment to Regent Policy 1D Freedom of Expression* that would require faculty, staff and students to add a disclaimer to any communication in "digital spaces" to distinguish between personal beliefs/statements and speaking on behalf of CU. <u>Representatives received an email from the BFA Office on September 10<sup>th</sup> with details.</u> Links provided in that communication included:
