OIEC services include:

- Case resolutions unit – addresses allegations/complaints of sexual misconduct or protected class for students, faculty, staff, or non-affiliates with concerns.
 - All complaints are investigated and reviewed but may not proceed to a formal investigation when a complainant doesn't want that option.

- Newspaper articles in the Denver Post and Daily Camera earlier in fall incorrectly noted that their office “chooses” to investigate or not.
- All complaints are tracked in OIEC records and are analyzed quarterly with Academic Affairs.
- See articles/opinion pieces in [CU Boulder Today](#) and the [Daily Camera \(10/11/24\)](#) noting OIEC process overviews and case data.
- **Support and safety measures unit** – help to make sure there are accommodations for folks who may be impacted in their living or work environment while a case is being investigated. A key area of concern related to this is around retaliation/accountability – complainant information may be withheld regarding OIEC process due to fear of retaliation. - Education, prevention, and assessment unit –
 - [Sexual assault and related harms survey](#) for students only opened Oct.22 and **closes Dec. 8** – conducted every four years. In 2021 it was combined with Campus Culture Survey, but the feedback was that it was too long. Campus Culture Survey for students, staff, and faculty will be given next year. Current student survey is much shorter and needs broad participation to assess what campus is doing as a community to help prevent harms from happening.

This survey goes out every 2-3 years to both students and course instructors of record (faculty, GPTI’s, TA’s) across colleges/schools. Survey asks about academic technologies they support (Canvas, Zoom, iClickers, software tools used in classes, etc.). Results overall were positive and didn’t note too many large gaps.

Notes and discussion items to share with constituents:

- Faculty are most interested in new technology that benefit student learning and save time
- Canvas and Classroom Capture were two most popular tools for both faculty & students
- Student comments noted that consistent faculty use and familiarity with Canvas is needed.
