# Senior Vice Chancellor for Research and Innovation and Dean of the Institutes Massimo Ruzzene Addresses BFA

- Answered questions on a range of topics from how to protect student rights in the classroom to grants should be dealt with in the light of the disruptions
- "This is a marathon, not a sprint...We must remain committed to our values. We need to support each other, and we need to remain confident that our excellent work and care for one another, for our students, will make a difference," said Ruzzene.

# **Retirements and Restructuring**

- BFA Chair Miller announced that they will retire in June 2025. "I really enjoyed my time in my many roles with BFA," Miller said.
- BFA Program Manager Howard and BFA Secretary Grove announced that they will retire in Jun 2025 also.
- These transitions have provided opportunity to reimagine certain roles, including a new faculty seat called the <u>faculty shared governance advisor</u>. This is a three-year position to be filled by a faculty member with broad campus experience. Their job will be to advise the BFA officers and consult with college and school faculty governance bodies on campus faculty shared governance issues.
- Additionally, based on motions approved in December, the Bylaws committee and ExCom have proposed a new title of BFA Parliamentarian & Bylaws and Elections Chair since the secretary role will expand to include some elements of the previous vice chair:

- Faculty with interest in running for upcoming BFA officer seats should reach out to Miller. Officer elections will be held in April and May.

# **Additional Updates**

- The BFA / Center for Teaching and Learning working group on generative AI has created syllabus guidance, and faculty are encouraged to <u>view the</u> <u>guidance</u> and join the working group, which meets on Fridays.
- A motion was introduced recommending faculty include generative AI guidance on their syllabus statements based on this guidance.
