

BFA Diversity Committee Resolution on BFA Support for a Self-Sufficiency Wage for Graduate Students at CU Boulder BFA-R-1-020118 (with Friendly Amendments)

**Whereas** the Boulder-based Committee on Rights and Compensation (CRC) has identified that many of CU-Boulder's graduate students are paid only approximately two-thirds of a Boulder self-sufficiency wage standard<sup>1</sup>; and

**Whereas** recent estimates of the cost of living in Boulder county place CU-Boulder's graduate students at a deficit of on average \$9500 per year<sup>2</sup>; and

**Whereas** graduate student compensation directly affects the ability of graduate programs to recruit and retain talented and diverse students; and

**Whereas** recent and planned increases in graduate student compensation are important steps in the right direction but still fall far short of Colorado's self-sufficiency wage standard<sup>3</sup>; and

**Whereas** graduate students -- in their multifaceted roles as students, teachers, and researchers -- make essential contributions to the research and teaching missions the University, enhancing both the intellectual and economic vitality of the University; and

**Whereas** the Chancellor of CU-Boulder has challenged us to "... engage, for the first time in our history, in a comprehensive effort to craft a strategic plan for diversity, equity and inclusive excellence"<sup>4</sup>; and

**Whereas** adequate compensation is one of the keys to a vibrant, diverse, and equitable graduate program<sup>5</sup>;

be it now therefore

**Resolved**, that the Boulder Faculty Assembly urges CU-Boulder's leadership and administration to take even more decisive, aggressive, and rapid action to ensure that the combination of graduate student salaries and summer support meets or exceeds the Colorado self-sufficiency wage standard and to adjust salaries and support each year to meet or exceed this standard. The BFA recognizes that there is currently great heterogeneity across departments, units, and institutes in 12-month graduate student salaries and support. Reaching a self-sufficiency wage would likely occur through different mechanisms in different units.
