- VI. <u>DEI in Annual Merit Review Process Update</u> Andrea Feldman, BFA Diversity Chair Feldman reviewed survey data gathered from the Faculty Salary Procedures Working Group on units are incorporating <u>diversity</u>, equity, and inclusion work into faculty merit reviews. - VII. Chancellor Search Committee Update Shelly Miller, BFA Chair

The BFA submitted a list of thirty-three faculty nominations as submitted to the BFA Executive Committee. Miller met with President Saliman and requested that eight seats be reserved for faculty on the search committee with a mix from colleges/schools/institutes as well as both tenure/tenure-track and teaching/clinical faculty. Saliman will also be speaking to faculty at the February 1, 2024 Assembly meeting.
