The University of Colorado Board of Regents must take the necessary measures to ensure the safety and wellbeing of all members of the University of Colorado System. Banning concealed carry across all University of Colorado campuses will reaffirm past Regent policy that existed for over 40 years. Students, staff, faculty, and community members alike support this life-saving measure. As the representatives of the faculty, the University of Colorado Boulder Faculty Assembly calls on the Board of Regents to prioritize the safety of the communities they govern with respect to gun safety.

Whereas, the presence of a firearm increases the likelihood of injury or death<sup>6,7,8,9</sup>, and;

**Whereas,** Faculty have expressed concern regarding the concealed carry policy on campus<sup>10</sup>, and;

**Whereas,** the University of Colorado Boulder Student Government (CUSG) passed resolution 97 LCR 08 *A Resolution Calling on the University of Colorado Board of Regents to Ban Concealed Carry*, which the Boulder Faculty Assembly voted overwhelmingly in favor on Oct 6, 2022, and;
