Whereas the current BFA Bylaws and Standing Rules still define and allow non-uniform service terms for BFA officers;

Whereas this non-uniformity leads to unnecessary record keeping and confusion within the BFA membership;

therefore, the BFA Bylaws committee now

Moves, that:

1. the BFA Bylaws and Standing Rules define the terms of all BFA officers (Chair, Vice Chair, Secretary), to be two years in duration upon initial election, with an option to run again for a third year; and
2. until unnecessary, described members in their first year of service shall be allowed to run for election for a two year extension to bring their service term to three; and
3. until unnecessary, described members in their second year of service shall be allowed to run for election for a one year extension to bring their service term to three; and
4. the Bylaws and Standing Rules documents be changed, as appropriate and necessary, to reflect these uniform three-year maximum service intervals.

<p>ARTICLE III: Officers and Executive Committee Members-at-Large</p> <p>Section 1. The Officers of the Assembly shall be the Chair, Vice Chair, and Secretary. The Chair is initially elected to a term of two years. The Vice Chair and Secretary are initially elected to a term of one year. There shall also be two Executive Committee Members-at-Large, and each serves a term of two years. The Officers and the Executive Committee Members-at-Large shall be elected by the members of the Assembly in an open meeting as provided in the Standing Rules.</p> <p>Section 2. Officers of the Assembly and Executive Committee Members-at-Large shall be duly elected or appointed representatives of a department, unit(s), or the campus.</p> <p>Section 3. Officers of the Assembly may be re-elected for a second term of one year. Upon completion of a second consecutive term, the Officers are not eligible to run for the same position for a period of one year. Upon completion of their initial two-year term, the Executive Committee Members-at-Large are not eligible to run for the same position for a period of one year.</p>	<p>ARTICLE III: Officers and Executive Committee Members-at-Large</p> <p>Section 1. The Officers of the Assembly shall be the Chair, Vice Chair, and Secretary. The Officers are initially elected to a term of two years. The Vice Chair and Secretary are initially elected to a term of one year. There shall also be two Executive Committee Members-at-Large, and upon initial election each serves a term of three years. The Officers and the Executive Committee Members-at-Large shall be elected by the current voting members of the Assembly in an open meeting as provided in the Standing Rules.</p> <p>Section 2. Officers of the Assembly and Executive Committee Members-at-Large shall be duly elected or appointed representatives of a department, unit(s), or the campus.</p> <p>Section 3. Officers of the Assembly and the Executive Committee Members-at-Large may be re-elected for a second term of one year. Upon completion of a second consecutive term, the Officers and Executive Committee Members-at-Large are not eligible to run for the same position for a period of one year. Upon completion of their initial two-year term, the Executive Committee Members-at-Large are not eligible to run for the same position for a period of one year.</p>	<p>ARTICLE III: Officers and Executive Committee Members-at-Large</p> <p>All seats are for an initial two-year term, with a possible re-election for an addition year. After a one-year hiatus from the position, members may run again for the same position.</p>

<p>ARTICLE V: Standing and Ad-Hoc Committees</p> <p>Section 3. Standing committee members may serve for two consecutive terms of three years each. A member may serve again but not until at least a year has passed since the member was last on said committee.</p> <p>If a committee member misses three consecutive regular meetings of the committee, he or she will be considered to have resigned committee membership. The vacancy will be filled as provided by the Standing Rules of the Boulder Faculty Assembly.</p> <p>Section 6. Chairs may serve for two consecutive terms of two years each. A member may not serve again as chair until one year has elapsed.</p>	<p>ARTICLE V: Standing and Ad-Hoc Committees</p> <p>Section 3. Standing committee members may serve for two consecutive terms of three years each. A member may serve again but not until at least a year has passed since the member was last on said committee.</p> <p>If a committee member misses three consecutive regular meetings of the committee, he or she will be considered to have resigned committee membership. The vacancy will be filled as provided by the Standing Rules of the Boulder Faculty Assembly.</p> <p>Section 6. Chairs may serve for two consecutive terms of three years each, but may not to exceed their membership on the committee. A member may not serve again as chair until one year has elapsed.</p>	<p>ARTICLE V: Standing and Ad-Hoc Committees</p> <p>All seats are for an initial three-year term, with a possible re-election for an addition three-year term. After a one-year hiatus from the position, members may run again for the same position.</p>
