



## **BFA General Assembly**

### Meeting Minutes

*Thursday, September 7, 2023*

The Boulder Faculty Assembly held a regular meeting on Thursday, September 7, 2023, via Zoom. BFA Chair Shelly Miller presided over the meeting. Miller welcomed new and returning members and read the CU Land Acknowledgement statement. The meeting convened at 4:00 p.m. and was adjourned at 5:30 p.m.

- I. BFA Administrator Appraisal Report on Provost Moore – Fernando Rosario-Ortiz, AAPC Chair
- II. The AAPC spent much of last year revising and updating the administrator appraisal process. The new model is based on the Academic Leadership Competency Model. Provost Russell Moore was the first administrator to be reviewed by this new process, and the results were presented to the BFA Executive Committee in May of 2023. Rosario-Ortiz reviewed results and asked representatives to email any feedback to him. The committee plans on creating guidelines to be used for administrator appraisals across campus in the colleges and schools. Feedback from members included:
  - Consider increasing the percentage of faculty queried to 30-40% instead of 20%.
  - Separate out teaching/clinical faculty responses if possible.

Campus Libraries and the BFA Executive Committee introduced a resolution outlining campus priorities to help negotiate licensing agreements with publishers. - IV. CU Boulder Campus Building Safety Policy –

Chief People Officer Robyn Fergus spoke to representatives regarding an August payroll calendar issue that resulted in smaller paychecks for many faculty. Representatives were asked to let their colleagues know to contact their unit's HR liaison if interested in an advance pay option to assist with the impact. The BFA will be coordinating with campus HR going forward to improve communication between groups.
