Rates published by the Bursar's Office are approved by the Board of Regents. The Board of Regents reserves the right to change rates at any time. Tuition charged is based on residency classification, degree and number of credit hours. Fractional credit hours outside of flat rate tuition are assessed the average rate between the two closest credit hours. Dual degrees are charged the higher rate. These rates apply to Boulder Main Campus only. Classes taken on different campuses including Boulder Main Campus and Continuing Education incur separate tuition and fees and are billed separately. Rates and deadlines may be subject to change.

¹ Most graduate student statuses are assigned automatically based on the student's registration. Status D is assigned by the graduate school. Students must have passed their comprehensive exam and must have been admitted to candidacy before this status can be changed. NEW! FEE WAIVERS FOR GRADUATE ASSISTANTS

OTHER REQUIRED FEES

A&S (ASSET) FEE \$1.32 PER CREDIT HOUR PER SEMESTER

Applies to all classes in the College of Arts and Sciences regardless of a student's major or program of study.

APPLICATION FEE

One-time nonrefundable application fee for graduate students. This fee is not waived for graduate assistants. \$60 for domestic applicants \$80 for international applicants

IMMIGRATION COMPLIANCE FEE \$40 PER SEMESTER

One-time nonrefundable application fee for domestic graduate students. This fee is not waived for graduate assistants.

NEW STUDENT FEE

One-time nonrefundable fee upon entering a degree program. This fee is not waived for graduate assistants. New domestic graduate students and transfers \$62 New international graduate students and transfers \$145
