The Board of Regents reserves the right to change tuition and fees at any time. Tuition is based on residency classification, number of credit hours and your college, school or program. Fractional credit hours are assessed a portion of tuition between the two closest credit hours. Dual degrees and double majors are charged the higher rate. These rates apply to Boulder Main Campus only. Classes taken on different campuses including CU Boulder Online and Continuing Education have separate tuition, fees and billing. Costs listed on this sheet are billed directly by CU Boulder but may not include everything. See Understanding Your Cost of Attendance (colorado.edu/understand-your-cost-attendance). For example, if a student is enrolled in B Session classes but no classes before that, they would need to purchase a membership to have access prior to the first day of B Session (colorado.edu/recreation/facilities/membership-and-lockers/membership-rates).
