#### **OTHER REQUIRED FEES**

#### A&S (ASSET) FEE \$1.32 PER CREDIT HOUR PER SEMESTER

Applies to all classes in the College of Arts and Sciences regardless of a student's major or program of study.

#### **APPLICATION FEE**

One-time nonrefundable application fee for graduate students. This fee is not waived for graduate assistants.
