All students are required to have health insurance while attending CU Boulder. Students must meet this requirement their first semester at CU Boulder and at the beginning of each academic year. Graduate students enrolled in one or more credit hours are required to complete the health insurance requirement process by the published deadline in order to avoid automatic enrollment in the SHIP along with a charge on the tuition bill. MASTER'S STUDENT STATUS

- A** - registered for coursework and/or master's thesis hours
- B** - registered for "candidate for degree", course #6940–6949 (Students who are required to be registered for thesis defense or master's final exam but have no courses or thesis hours left to take, and/or students who must remain full time. A maximum of 3 hours should be taken per semester, as this registration placeholder cannot be used toward a student's degree.)

DOCTORAL STUDENT STATUS

- C** - Pre-comprehensive exam - registered for coursework or coursework/dissertation hour combination
- D** - Post-comprehensive exam - registered for 3 or 5+ dissertation hours as required by graduate school rules (status is assigned by the graduate school following admission to candidacy)
- E** - Pre-comprehensive exam - registered for dissertation hours only

BILLING

Bills are online only. Students access billing information in the student portal once they are enrolled. Parents and other family members need to get access from their students in order to view the bill. Students authorize payers in the student portal. Authorized payers access billing information in CUBill&Pay.

PAYMENTS

Fall payment is due on September 5. Spring payment is due on February 5. We encourage online payment from a checking or savings account (called eCheck) in order to avoid a non-refundable 2.75 percent service fee (charged by NelNet Business Solutions) for each credit/debit card payment. We accept American Express, MasterCard, Visa and Discover.

PAYMENT PLANS (enrollment fee \$25)
