How to view the 1098-T form and details in MyCUInfo

- CU Boulder cannot provide 1098-T forms directly to parents or others because of <u>federal privacy laws</u>.
- If the student is claimed as a dependent on another person's tax return (such as a parent), the student can download the form and give the 1098-T tax form directly to that person.
- 1098-T forms are only online. No forms are mailed.
