All requirements must be completed by the end of the semester in which you apply to be eligible for admission.

1. **24 credit hours completed** (12 must be graded coursework at CU-Boulder).
2. **CU Cumulative GPA of 3.20** or higher.
3. **Completion of 4 IUT courses** (ECON 2010, ECON 2020, MATH 1112, Statistics) **with grade of “B” or higher.**
4. **Submit IUT application form by the posted deadline.** Application form & key dates are listed on [Leeds IUT webpage](#).

Statistics	4 Statistics Must earn “B” grade or higher. MATH 2510 is recommended; OR choose from: APPM 3570, CHEN 3010, CVEN 3227, ECON 3818, INFO 1301, IPHY 3280, MATH 3510, MATH 4510, PSCI 2075, PSYC 2111, PSYC 3101, SOCY 2061, or STAT 4000).	Must earn “B” grade or higher. Transfer credit accepted from: • Colorado community colleges for courses equivalent to MATH 2510 on Transferology. • OR courses equivalent to MATH 2510 with ‘BCM’ iflag on Transferology. • OR courses equivalent to BCOR 1025 on Transferology. For statistics courses already taken, you must submit the course syllabus for evaluation to LeedsIUT@colorado.edu .	AP Statistics does NOT fulfill the Leeds IUT statistics requirement.
