BS in Business Administration: Accounting BAM with Summer Internship

Catalog Years 2025-2026

The Bachelor's Accelerated Master's (BAM) program allows students to complete the bachelor's and master's degrees in five years and is designed to be a 4+1 program. This plan outlines the path to completing the BS degree. Students are allowed to take up to 12 credits of MS courses while in the undergrad program and can apply a maximum of 9 MS credits toward their BS degree. If you are considering the BAM option, you should work closely with your academic advisor to make sure you meet the requirements and are on track for both programs. *CPA eligibility requires 150 credits in most states so it is ideal for students on this track to graduate with 132 credits including three MS/BS overlapping courses and one MS course.
