



MS Supply Chain Management Program Plan

The MS Supply Chain Management provides an in-depth education in the area of Supply Chain Management. This 10-month program includes extensive coursework which prepares students for a range of job opportunities. In addition to the academic coursework, four enrichment seminars in topics ranging from teamwork and leadership to ethics and corporate social responsibility support our commitment to developing the "whole student," by incorporating professional development into the academic experience.

Based on an "action learning" model, the program is designed to provide hands-on supply chain project management experience, amplified by shared experiences with other students. Admissions to the program may require preparation or refresher courses in statistics, math and business.

Graduates will be prepared for responsible and influential jobs in a variety of organizations, including large manufacturing, retail, and distribution organizations; transportation companies; supply chain software companies; and supply chain consulting firms.

Admission to the MBA and MS Programs is competitive. The admission committee conducts a holistic review of each application in order to select the most talented and diverse incoming class. Admission decisions are based on an evaluation of a number of criteria including, but not limited to, academic competitiveness (undergraduate GPA and coursework completed, test scores, undergraduate institution, etc.), professional work experience, essays, letters of recommendation, interviews, and program fit.

2021-2022 Application Deadlines

Applications are accepted after August 5, 2021. Candidates are encouraged to apply early for best admission and scholarship consideration. International applicants should apply by Review 3 to allow sufficient time for the visa process. The MS Accounting and MS Taxation Programs provide specific deadlines for international students.
