PhD program at Leeds

The PhD Program at the University of Colorado Leeds School of Business challenges you to investigate complex questions and innovative ideas, while working closely with prominent faculty and scholars to generate groundbreaking research. The program prepares you for research and teaching careers at leading universities—recent graduates have accepted tenure-track positions at Indiana University, University of Georgia, University of Melbourne and Tulane.

Choose your discipline

Leeds PhD students study all academic disciplines and focus their research on advancing one key area.



Accounting

Examine corporate disclosure, information intermediaries, market microstructure, corporate governance, executive compensation, and standard setting.



Finance

Study corporate finance, structure of securities markets, valuation and asset pricing, derivatives, corporate governance, and information economics.



Marketing

Explore the drivers of consumer behavior, mechanisms of consumer decision-making and indicators of firms' strategic success.



Organizational Behavior and Information Systems

Focus on leadership, diversity, emotions, teams, machine learning, behavioral information security, natural language processing, cognitive information processing and technology utilization.



Strategy, Entrepreneurship and Operations

Work closely with renowned scholars on firm strategy, innovation, entrepreneurship, pricing and revenue management, supply chain management and logistics.

Explore funding options

Leeds automatically considers applicants for full funding if they meet the December 1 application deadline. Doctoral students receive full tuition waivers, support for a premium health insurance plan, and a \$30,000 annual stipend to work as research/teaching assistants.

Additional funding is available through other sources, including teaching and fellowships. PhD students are encouraged to apply for the summer Gerald Hart Doctoral Research Fellowship--designed to encourage early involvement in scholarly research and publication with a faculty member.



Below are the general requirements to complete a PhD in Business Administration (specifics vary between academic disciplines):

Coursework

Complete at least 30 credits of graduate-level work in your discipline.

• Math Camp & Economics Preliminary Examination

Finance and Accounting students must attend and pass Math Camp before the start of their first year. Finance students must pass an economic preliminary examination prior to the start of their second year.

• Comprehensive Examination/Second Year Papers

Demonstrate comprehension of coursework through an examination or second year research paper in your academic discipline.

 Teaching Serve as a teaching apprentice for three sections of a course, then independently teach two courses of your own.

Dissertation Hours Complete at least 30 credits of dissertation hours.

 Dissertation Proposal Defense Develop, present and successfully defend your dissertation proposal.

Final Oral Dissertation Defense Demonstrate your expertise in the theory and methodology of your specific research in your academic discipline.

Application materials



GMAT OR GRE

Submit official GMAT or GRE scores that are less than 5 years old regardless of the applicant's previous educational experience.



PROVIDE THE FOLLOWING:

A current vitae/resume

Three letters of recommendation

One set of unofficial transcripts



BACHELOR'S

DEGREE (or equivalent) Hold at least a baccalaureate degree or its equivalent from an accredited college or university.



ENGLISH PROFICIENCY

Be proficient in English. Scores from the TOEFL or IELTS are required unless your native language is English.



PERSONAL STATEMENT

Provide a personal statement that explicitly addresses your academic interests, including research interests and career objectives.

The deadline to apply for admission is **December 1**. All applications received by that date are automatically considered for student funding.
