

Dear CHA Supporter,

Coping With COVID-19



We sponsored a contest for CU Boulder students, staff, and faculty to produce works of art and humanities responding to COVID-19 as <u>Shelter Projects</u> (and we'll be displaying these on-line in the fall), and we have an on-going series, <u>Pandemic Posts</u>, where we invite our community to share their reflections on life during COVID-19.


Small Grants

The <u>CHA Small Grant program</u> provides up to \$3,000 for CU Boulder faculty to deepen and enrich the range of humanistic and artistic activities on campus and enhance faculty scholarship. During 2019-2020, the CHA Faculty Steering Committee recommended awarding a total of \$102,808 to fund 52 projects supporting research, creative work, special events, and presentations by visiting scholars and artists.

Hazel Barnes Flat

The <u>Hazel Barnes Flat</u> in the heart of London is a gift to scholars in the humanities and arts made by Hazel Barnes, the much-admired Professor of Philosophy at CU Boulder and founder of the Interdisciplinary Program in the Humanities. Since 2010, the flat has provided opportunities to conduct scholarly research in and around London to CU Boulder faculty and graduate students. Management of the flat has been entrusted to the CHA since its inception.
