Conditions of Imaging Requests

Request Submittal

All imaging requests, including all attachments, must be submitted to the Paleontology Section no later than two weeks prior to the date(s) the specimen(s) are needed. All requests will be reviewed by the curator and collection manager of the collection whose specimens belong to. Any requests for commercial use will only be approved if it conforms to the mission of the CUMNH and the research aims of the Paleontology Section. After approval, the specimen(s) requested will be loaned to the principal investigator/authorized agent. The principal investigator/authorized agent must agree to the requirements and conditions for outgoing loans as stipulated in the Paleontology Section's Collections Management Policy. The Paleontology Section reserves the right to deny any imaging requests and limit the number of specimens that will be used in the request at its discretion.

Financial Responsibility

All costs of the imaging, replication/reproduction, or other authorized methods and uses are the responsibility of the principal investigator/authorized agent unless otherwise indicated in writing.

Use of Unauthorized Methods, Procedures, or Techniques

If publishing, the principal investigator/authorized agent agrees to publish the supplied images only in accordance with the terms of this agreement. Furthermore, the licensee shall not assign this permission to any third party without the proper express written consent of the CUMNH, and any purported assignment without such consent shall be void. Any unauthorized imaging, replication, reproduction, or the use of other methods, procedures, or techniques conducted without the knowledge or consent of the Paleontology Section will result in immediate suspension of loans, access, and future use of the collections.

Return of Specimen(s)

After using the specimen(s) and images the principal investigator/authorized agent is required to send all information, images (including photographs, surface scans, CT scans, etc.), contact sheets, exposures, and any data gained from the project to the Paleontology Section so that it can be included in the catalog record for the specimen(s). The principal investigator/authorized agent is permitted to keep any computerized 3D models produced in the imaging or replication/reproduction process. All permissions are for one-time use only. Any future imaging and replications/reproductions must be approved by the Curator and Collection Manager.

Copyright and Licensing

All images, illustrations, or other depictions of Paleontology Section specimens taken by CUMNH staff, except for faculty, are copyrighted by the CUMNH. By signing this form, the principal investigator/authorized agent agrees to transfer all copyrights and intellectual property rights of all the images taken for this project to the CUMNH.

All images, illustrations, or other depictions of Paleontology Section specimens taken by CUMNH staff, except for faculty, are held under the Creative Commons Attribution-NonCommercial 4.0 International Public License (CC BY-NC 4.0). The principal investigator/authorized agent is required to apply the CC BY-NC 4.0 license to any image, illustration, or other depiction of Paleontology Section specimens that they create.

The principal investigator/authorized agent may not share, copy, redistribute, adapt, remix, transform, build upon or alter the image(s) without approval. The principal investigator/authorized agent may not use the images, illustrations, or other depictions for commercial purposes without approval. Any future imaging or image needs that are not included in the initial request must be approved by the curator and collection manager. Additional usage fees may apply to any future imaging or image needs.

Credit

The principal investigator/authorized agent must give credit to the University of Colorado Museum of Natural History, and in some cases the federal or state government agency owner of the specimen(s), in any publications, professional papers, images, replications, presentations, exhibit labels, or other media bearing images of Paleontology Section specimen(s). The credit line must include the catalog number of the specimen imaged, the CC BY-NC 4.0 (which should be a link to the CC BY-NC 4.0 webpage, otherwise provide a link to the license at the end of the credit line), the ear the image was created, and the name of the CUMNH written as "University of Colorado Museum of Natural History Paleontology Section" The proper name of the federal or state government agency owner will be provided when necessary. The principal investigator/authorized agent will send copies of any publications, professional papers, exhibit labels, or other media bearing the images of Paleontology Section specimen(s) to the CUMNH, and in some cases the federal or state government agency.
