INSTRUCTOR BIO

Murat lyigun, PhD, Brown University, 1995, is a professor specializing in the economics of the family, economic development & growth and cliometrics. He is a Research Fellow at the Institute for the Study of Labor (IZA), Bonn, Germany and a founding Fellow of the Association for Analytical Learning on Islam and Muslim Societies (AALIMS). Prior to joining the faculty in 2000, he served as a staff economist at the Federal Reserve Board in Washington, D.C. Some of Professor lyigun's research has been published in top economics journals, such as the *American Economic Review*, *Quarterly Journal of Economics*, the *Review of Economic Studies* and other leading journals. He is currently the co-editor of the *Journal of Demographic Economics* (JODE) published by Cambridge University Press and an editorial board member of *Journal of Economics*, *Management & Religion* (JEMAR) by Elsevier Press. His general-interest book, "War Peace and Prosperity in the Name of God," was published by the University of Chicago Press in March 2015.

Course Description

This is an introductory class on macroeconomics, which is the study of the performance, structure, behavior and decision-making of an entire economy. The course is designed to provide students with a comprehensive framework for analyzing macroeconomic events and issues. The topics we shall cover throughout the semester include the determination of output, unemployment, inflation, interest rates, exchange rates, business cycles, and long- run economic growth. The questions of concern will include: Why are some countries rich and others hopelessly poor? What

are the sources of economics booms and recessions? Why is there unemployment? What are the sources of inflation? And, how do government policies affect output, inflation and unemployment?

COURSE PREREQUISITES

There are no required prerequisites for this class. HOWEVER, a familiarity with the content of Principle of Microeconomics (ECON 2010) as well as a firm understanding of the basics of introductory calculus (Math for Economists, ECON 1078, 1088) would be most advantageous.

COURSE OBJECTIVES

By the end of the course you should be able to:

- Identify the key principles of economics and what role they play in individual behavior, market interactions and outcomes.
- Understand the role of economic models and how they help in studying macroeconomic questions.
- Comprehend the role of specialization and trade in generating economic efficiencies, while recognizing that trade and globalization affect the income distribution within societies.
- Understand how incomes, output, prices, unemployment are defined and measured.
- Identify how flows of goods and services and investments across borders are tightly related.
- Have a grasp of what influences economic growth and development.
- Identify why there is unemployment in the long run and the short run.
- Understand why there are business cycles in the economy and what roles monetary and fiscal policies can play in mitigating their adverse effects.

REQUIRED COURSE MATERIALS

INSTRUCTIONAL METHODOLOGY AND DELIVERY

This course is delivered via distance education format using the CU Canvas system. This format will use a combination of readings, online discussion, and other web-based resources. You will interact with the instructor and other students using the communication functions provided by Canvas. You will submit assignments in accordance with the course outline using Canvas.

COURSE PRESENTATION AND PROCEDURES

There will be 16 modules corresponding to the 14 weeks of the course (one module per week except during the midterm and final weeks when we have two modules). You should proceed through one modules per week, which will be comprised of readings from the course texts, supplemental class notes, homeworks and quizzes, exams, and various outside sources of information such as additional readings and video content, among other content. During the midterm and final weeks, you will cover exam review and preparation modules (Modules 7 and 15) in the first part of the relevant weeks. Then, you will take the exams in the second part of the week (Modules 8 and 16).
