Exams: Exams can be completed without the use of a calculator. You may use a non-graphing calculator which can assist in addition, subtraction, multiplication or division. I will not give makeup exams, except in extraordinary situations. If you miss an exam for any reason, your final will count as 50% of your overall grade. Note that the exams may not be intentionally comprehensive, but this material is inherently comprehensive therefore the exams may include material from previous sections. The final exam however, will be cumulative.

Homework: I will be assigning weekly homework. I do this because mathematics is not a spectator sport. The only way to succeed when it comes to learning mathematics is practice, practice, practice. The weekly homework will be assigned on Monday and due the following Wednesday in class. I will drop the lowest homework grade. I do not accept late homework. If you miss class the day the homework is due, you must send me an email containing a picture of your completed homework, and then I will accept the hard copy the next class you attend.

Note: your cumulative homework grade is the same portion of your grade as one exam. Please take advantage of this and take the homework seriously! You are welcome to work with classmates and see me in office hours if you are having trouble completing the assignments.

Participation: This portion of your grade will come entirely from the clicker questions. This part of your grade is based off **completion**. This means whether or not you answer the clicker question correctly is irrelevant. As long as you are in class that day, answering the questions, you will get credit. I will drop the 3 lowest to account for absences. If you forget your clicker, you cannot receive credit for that day. It is your responsibility to bring the clicker to each class.
