## Course Content:

This course builds an understanding of the basic mathematical tools used in the economic field. As an applied course, there will be plenty of hands-on practice using examples that relate to both real world and common economic problems. The topics covered in this course will range from algebra to the basics of differentiation. The goal of this course is to provide students with a strong mathematical foundation in order to prepare them for future economics courses.

### Prerequisites:

There are no prerequisites for this class

### Required and Recommended Materials:

Required: Calculator. At least scientific level. Graphing calculators work fine.

### Recommended:

*Essential Mathematics for Economic Analysis* 3<sup>rd</sup> edition by Knut Sydsaeter and Peter Hammond This is the textbook that I will be using for this class. *This textbook is not required*, but can be a helpful resource. Finding a used copy, renting one or finding it in the library are the suggested ways to utilize this resource

### Homework:

Homework will be given weekly in the form of worksheets. These worksheets are to be printed out and returned by the due date assigned in class. I will post due dates as well as reminders on Canvas, *but all homework will be turned into my office or to me in person.* Late assignments will not be graded or awarded any credit unless previous accommodations have been made.

### Quizzes:

This class will not have any midterms. Instead, biweekly quizzes will be given to assess student understanding of the material. (Note: This method mean less cramming and stressing before large exams, and allows me as an instructor to have a better sense of what concepts students may be struggling with. These quizzes will always be given on Fridays unless otherwise noted in class. I will drop the lowest quiz score for each student at the end of the semester.

## Final Exam:

There is a mandatory, cumulative final exam for this course. The final exam will be held at the time scheduled according to the registrar.

### Grading:

Your final grade in this course will be determined as follows:

I will assign you a letter grade which will include +/-. I will strictly adhere to the assignment of your letter grade based on your percentage grade in the class. This means I will not individually curve your letter grade to "bump" it up a letter grade. (e.g. an 89.9% will be a B+ and I will not move it up to an A -) Please speak to me if you have concerns about your grade at any point in the semester.

Cheating will not be tolerated in this course. This includes cheating on an exam, in recitation, or by using another student's clicker during the lecture. *If you are caught cheating I will assign you an F in the course.* I will then meet with the Associate Chair of the Undergraduate Studies for the Economics Department, and we will report this to both the University and the Honor Council which could result in further discipline up to and including expulsion from the University.

### Attendance and Classroom Policy:

I do not require clickers. Attendance will be calculated through a sign-on sheet each day. It is your responsibility to make sure you sign in each lecture. While in lecture, use common courtesy to respect other students around you (i.e. Do not leave early/play games on phones/laptops/etc.)
