Course Description

Microeconomics, roughly speaking, is the study of how individuals and firms make decisions with limited resources. Throughout the course of this semester, we will explore such topics as preferences, supply, demand, market, taxes, government regulations, etc. This course serves as a prerequisite for ECON 2020, Principles of Macroeconomics, as well as many upper division economics courses.

Textbook and required material

The companion EconPortal access card is required for homework assignments. A Clicker is also required for in-class questions.

Prerequisites

There is no prerequisite for this course. However, a sound understanding of elementary algebra is essential to the successful completion of this course. At the very least, you should be familiar with plotting and inverting simple functions, as well as solving simple equations.

EconPortal Assignments. The EconPortal assignments are designed to reinforce your understanding of the course material and to familiarize you with types of questions that may appear on the exams. They may also help make up for a poorly performed or missed midterm exam; see the paragraph below for details.

Midterm Exams. There are two midterm exams, each of which consists of twenty multiple-choice questions and one short-answer question. I will drop the lowest of the following three scores: EconPortal assignments, Midterm I, and Midterm II. This implies that a missed midterm is replaced by your EconPortal assignments. As such, there will be no make-up midterm exam under any circumstances.

Final Exam. The final exam is cumulative and consists of fifty multiple-choice questions and three short-answer questions. The final exam score will not be dropped for any reason. If you require accommodation for the final exam due to scheduling conflict, it is your responsibility to inform me in a timely manner pursuant to the University's final exam policy, which can be found at http://www.colorado.edu/policies/final-examination-policy

Recitation. One of the four credit hours you will earn for this course comes from your recitation. Therefore, your performance in the recitation accounts for a quarter of your final score. Your recitation score is determined by the Teaching Assistant who leads your recitation section. **Important:** recitations do not begin until the 2nd week of instruction.

Clicker Questions. Clicker questions are assigned during lectures as a means both to check your understanding of the material and to incentivize attendance. The score is determined solely by the percentage of questions answered, regardless of whether your answers were correct.

Letter Grade. Curving may be applied at the instructor's discretion but it should not be expected. Your final score will be rounded to the nearest one decimal place and your final grade is determined as follows:
