Course Description and Objectives: Economics is the study of how agents (humans, firms, etc...) make decisions under scarcity. Economists typically assume that these decisions are made in a rational manner. For this reason, in this course reasoning skills will be much more important than memorization skills. This course will provide an introduction to the economic thought process which will hopefully benefit you in your future studies. Specifically we will study how consumers and businesses make decisions, how markets work as well as how they fail, and how government actions affect markets.

Exams: You may drop your lowest midterm exam score and replace it with your recitation grade if your recitation grade is higher than your lowest exam score. THERE WILL BE NO MAKE-UP EXAMS. If you cannot make an exam because of an emergency/other commitment you can drop the zero and replace it with your recitation grade. Graphing calculators are not allowed in exams. Failure to adhere to this policy will result in a zero for the assignment. You will also need to know your student ID number (the one found on MyCUInfo) prior to the exam. You will also need a #2 pencil.

In summary you need the following for each exam:

- 1. Your student ID Number
- 2. A #2 Pencil
- 3. A non-graphing calculator (optional)

Midterms will be due at the end of the 50 minutes alloted for class. Failure to turn in your exam in a timely fashion will result in a zero for that exam. This means if you bubble in your answers at the end of the exam, be sure to give yourself time to complete the task of bubbling. Taking extra time on an exam is cheating, even if you are just bubbling in the answers.

The Final The final exam will take place on **DATE NEEDED** in our normal classroom. Recitation may not replace your final exam score. The final exam is mandatory for all students. The same rules for the midterms apply to the Final.

As is university policy, you can reschedule your final exam only if you have three or more exams scheduled for the same day. If this is the case, you may have your exams rescheduled except for the first two exams

scheduled for of that day. However, you must request accommodations for this before the 10th week of classes.

Recitation: Recitation begins the second week of the semester. Grades for your recitation will be determined by your TA's and will be outlined in their syllabus. You must attend the recitation you are registered for.

FlipIt: You will have 3 types of assignments due on FlipIt:

- 1. **Pre-lecture:** These are sequences of videos and questions about the upcoming lecture. These are due at 8 AM the day of their respective lecture. The purpose of these questions and videos is to simply introduce you to the ideas that will be covered in class. These assignments should take you around 10 minutes to complete on average. If you simply complete the assignment you will earn 100% credit for the assignment. I will drop one (and only one) of these assignments automatically at the end of the semester.
- 2. **Bridge Questions:** These are questions that you will answer before class that are about the upcoming lecture. They are multiple choice questions along with a space for you to explain why you chose the answer you chose. These are due at 8 AM the day of their respective lecture. The purpose of these questions is to allow me to gain a better understanding of what topics I need to emphasize that day in lecture. We will review all of the bridge questions in class and you will have a chance to answer them again using iClickers in class. If you simply complete the assignment you will earn 100% credit for the assignment. I will drop one (and only one) of these assignments automatically at the end of the semester.
- 3. **Homework:** These assignments are completed after each lecture and consist of multiple choice questions. You will have 5 attempts to answer a variation of a question. If you are able to answer any variation of that question correctly you will receive full credit for that question. If you cannot answer one of the 5 variations correctly you will not receive credit for that question. I will drop one (and only one) of these assignments automatically at the end of the semester.

iClicker: During class I will randomly ask students to answer questions using their iClicker. It is your responsibility to make sure your clicker is registered to you. This can be done on MyCUInfo. Failure to do so will forfeit all points assigned to your iClicker grade. This is more than a week and a half of drops. For this reason I will not drop scores or excuse students for missed class or for a forgotten clicker.

You will receive 2 points for every clicker question you attempt and an extra point for each question you get correct. You are allowed and encouraged to discuss questions with your classmates. However you are not allowed to bring a classmate's clicker to class. If you are caught with more than 1 clicker you will be asked to leave class for the day, you will be given a grade of F for the semester, and your classmate (whose clicker you have) will also receive a grade of F for the semester.

3 Policies

Note that I reserve the right to change this syllabus at anytime. This is your contract for the course. Please pay attention to the policies and note that given notice I reserve the right to change them throughout the course.

Emails: This is a large class which makes answering every single email extremely costly. Therefore I will only respond to emails if they cannot be answered by the syllabus. In addition when I send out an email to the entire class and you have a follow up question I ask that you do not reply to my email. Please send me

a new email that way I am able to keep each student's question separate from others. Please allow 24 hours for me to respond on weekdays and 48 hours on weekends.

Laptops, Tablets, and Cell Phones: Laptops can be distracting to others in class. For this reason I ask that if you use your laptop to take notes you sit in the first 4 rows of class so I can ensure you are indeed not distracting those behind you. PDF copies of the slides will be posted prior to class and you are more than welcome to download them to your laptop or tablet prior to class to annotate them. Please do not use your laptop for anything other than taking notes. If you are caught using your laptop for something other than taking notes you will be asked to leave. Please silence your cell phone prior to class and do not use it except in the case of emergencies.

Curving: There will be no individual curving. Please do not email me at the end of the semester asking for your grade to be changed. I will curve each exam so that the average is at a reasonable level. I will round your final grade up to the nearest whole number. Everyone in the class will receive an equal curve so do not ask for special treatment. I will not curve grades down. Recitations will be curved so that each TA's recitations have the same average.

Cheating: If you are caught cheating in any fashion (on exams, in recitation, or clickers (see above)) you will be given an F for the semester and your case will be reported to the Honor Code Council for review.

4 Tentative Schedule

It is important to note that **there is no recitation the first week of class** (the week of 1/17). Recitation begins on the second week of class (week of 1/23).
