### **Course Info**

Description: Principles of Microeconomics is an introductory undergraduate course that teaches the fundamentals of microeconomics. This course introduces microeconomic concepts and analysis, such as supply and demand analysis, theories of the firm and consumer behavior, competition and monopoly, and welfare economics. Students will also be introduced to the use of microeconomic applications to address problems in current economic policy throughout the semester.

### **Required Material and Textbook:**

**MindTap**: Students in this course are **required** to use MindTap to complete homework. MindTap is an online course platform that enable online access to homework, textbooks and study tools.

**Prerequisites**: Being able to read mathematical graphs and solving algebraic equations quickly is necessary for this course.

Extra Credit and Lecture Attendance: Extra credits are available by coming to the lectures regularly. The lecture attendance is not required. But students that regularly come to lectures can earn up to 4% bonus towards their final grades. So, the maximum grade that a student can earn is 104%. There are roughly 30 lectures in the fall semester. There are around 24 lectures that I will record attendance. Attendance will be taken before 8:20 am during each lecture using the *iClicker* APP.

Recitations are mandatory and account for 10% of your total grades. In recitations, you will meet your teaching assistant to complete a worksheet each time. Recitation grades are based on attendance only. Talk to you TA regularly and keep track of your attendance grades during the semester. One of the recitation absences will be dropped. If you miss more than 1 recitations, the extra absences will negatively affect your grades. The goal of recitation is to ask question, solve homework questions, review concepts, and practice for the exams. You will meet twice a week with one of the TAs for this course. Your TA will offer a worksheet in recitation and you need to complete the worksheet with your TA. The worksheets are closely related to the homework and exams. Thus, it is essential to attend the recitation and study the worksheets.

Recitations don't start until the second week.

Late policy: Any late submission of homework will not be accepted and will receive a grade of zero. No extension will be given for regular reasons. In case of an extreme illness, proper documentation will be required for all missed assignments. A time-stamped note from Wardenburg does not qualify as an extreme illness.

**Homework assignment on** *MindTap***:** Homework is an important part of this course as it accounts for 20% of grades. There are 19 homework assignments in total, and the lowest 3 will be dropped when calculating final grades. There is at least a homework assignment due every week except for the first week. Most of them are due on Sunday at 11:59 pm. Make sure to frequently check the *MindTap* page and keep track of the due dates.
