Course Content:

In this course we will discuss foundational topics in macroeconomics. This will include discussions on trade, national production, unemployment, business cycles, and monetary/fiscal policy. My goal for this course is to provide you with a strong framework for understanding the economy as a whole that will enable you to understand a variety of common topics in macroeconomics.

Prerequisites:

The prerequisite for this course is ECON 2010, Principles of Microeconomics. Please let me know immediately if you do not fulfill the prerequisites for this course. Failure to discuss this with me may result in your withdrawal from the course.

Lectures:

I will use lecture time to discuss new material, go over examples, and work through homework assignments in order to prepare for exams. Attendance will be taken in each lecture using clickers in order to answer questions related to the material. You are required to answer every clicker question in order to earn attendance points for the day. Missing any clicker question will result in a zero for the day. Any technical difficulties with your clicker must be addressed with me on that day in order for me to provide you with attendance points. You may have three unexcused absences throughout the semester. Each lecture you miss beyond your unexcused absences will count equally against your attendance grade. All material that I discuss in lecture will be required knowledge for the exams. Please do not use any electronic devices for anything unrelated to this course. Anyone who is distracting or refuses to participate during lecture will be asked to leave. Attendance will be taken in the first week of class. Students who do not attend class every lecture during the first week will be administratively dropped. I will not

distribute my lecture notes or repeat lectures to students who are unable to attend. It will be your responsibility to obtain notes from your classmates if you need to make up a lecture.

Exams:

Midterm exams will be held in class during lecture time. There will be three midterm exams and a cumulative final exam. Your lowest midterm grade will be dropped and your two highest midterm grades will be worth 20% of your grade each. The final exam will be worth 25% of your grade and will not be dropped. Anyone who has three or more final exams on the same day in which my final exam is your latest exam of the day may notify me before March 24th and schedule an alternative time for their exam. *There will be no make-up exams.*

Grading:

Your final grade in this course will be determined as follows:

I will assign you a letter grade which will include +/-. I will strictly adhere to the assignment of your letter grade based on your percentage grade in the class. This means I will not individually curve your grade to move it up a letter grade (e.g. an 89.9% will be a B+, I will not move it up to an A-). Please speak to me if you have concerns about your grade at any point in the semester. *Cheating will not be tolerated in this course*. This includes cheating on an exam, cheating in recitation, or cheating by using another student's clicker during lecture. If you are caught cheating I will assign you a 0% in the course. I will then meet with the Associate Chair of Undergraduate Studies for the Economics Department, and we will report this to both the University and the Honor Council to decide upon further punishment, which could include expulsion from the University.

Homework:

I will post homework assignments to D2L throughout the semester. You will enter your homework answers on D2L. These assignments will be designed to provide you with a guideline for what type of material I am going to include on the exams. You are expected to complete

these assignments on time in order to receive points. Any technical difficulties in entering your answers to homework assignments must be reported to me prior to the deadline in order for me to consider providing you with additional time.
