Course Content:

We will discuss foundational topics in macroeconomics in this course. This will include discussions on trade, national production, unemployment, business cycles, and monetary/fiscal policy. My goal for this course is to provide you with a strong framework for understanding the economy as a whole, which will enable you to understand a variety of common topics in macroeconomics.

Prerequisites:

The prerequisite for this course is ECON 2010, Principles of Microeconomics. Please let me know immediately if you do not fulfill the prerequisite for this course. Failure to discuss this with me will result in your administrative withdrawal from the course.

Lectures:

I will use lecture time to discuss new material or go over example problems to prepare for exams. Attendance will be taken in each lecture using clickers to answer questions related to the material. You are required to answer every clicker question to earn attendance points for the day. Missing any clicker question will result in a zero for the day. You may have three unexcused absences throughout the semester. Each lecture you miss beyond your unexcused absences will count equally against your attendance grade. You must attend each of the first two lectures to remain enrolled in this course. Students who fail to record their attendance on any of these dates will be administratively dropped.

Quizzes and Exams:

There will be six quizzes throughout the semester worth a total of 20% of your grade. Your lowest quiz grade will be dropped, so that the remaining five quizzes account for 4% of your total grade. There will be one midterm worth 20% of your grade, and one final exam worth

30% of your grade. If it benefits you, I will allow your final exam grade to replace your entire grade in the course.

### Grading:

Your final grade in this course will be determined as follows:

Lecture Attendance: 15%

Recitation Grade: 10%

Quiz Grades: 25%

Midterm Grade: 20%

Final Exam Grade: 30%

I will assign you a letter grade which will include +/- . I will strictly adhere to the assignment of your letter grade based on your percentage grade in the class. This means I will not individually curve your grade to move it up a letter grade (e.g. an 89.9% will be a B+, I will not move it up to an A-). Please speak to me if you have concerns about your grade at any point in the semester.

Cheating will not be tolerated in this course. If you are caught cheating on an exam I will assign you a 0% in the course. I will then meet with the Associate Chair of Undergraduate Studies for the Economics Department, and we will report this to both the University and the Honor Council to decide upon further punishment, which could include expulsion from the University. I will attend any honor council hearing and personally provide evidence for an accusation of cheating.
