Course Objectives

In this course, we deal with the behavior of individual economic units. These units include consumers, workers, business firms—in fact, any individual that plays a role in the functioning of our economy. Microeconomics explains how and why these units make economic decisions. We will explore how these individual decisions affect the supply and demand for goods and services.

Prerequisites

Principles of Microeconomics (Econ 2010) or Introduction to Economics (ECON 1000) and Mathematics for Economists I and II (ECON 1078 & 1088) or MATH 1300 or MATH 1310 or equivalent

Grading

Your course grade will be determined by adding the points you received the two mid-term examinations, the final, the homework, and the class participation. Your course grade will be calculated as follows:

Examinations All exams will take place in the regular class room on the dates listed below.

Make-ups for any exam will be allowed under compelling circumstances. Any make-up exam will be taken prior to the actual exam date, so you are required to make prior arrangements before the exam date. Each exam will be composed of multiple choice and short answer questions. You should bring your simple calculator to the exam. Exam questions will be based on material covered in lecture and the problem sets. I will distribute the mock exam before the test. **Note that** if you have 3 or more final examinations on the same day, they can arrange to take the **Last Exam** scheduled that day at an alternate time. It is their responsibility to notify you no later than six weeks into the semester and they must provide proof that you are administering their 3rd, 4th, or 5th exam of the day.

Homework: There will be five problem sets but only the best four will be counted. The maximum score on each assignment will be 100 points. You could discuss homework questions with other students but you should turn it in with your own work. Due dates for each homework will be announced in advance and no late assignment will be accepted.

Participation: This will be based on your attendance and your participation during class.
