### **Course description**

What the website says: Intermediate macroeconomics introduces theories of aggregate economic activity including the determination of income, employment, and prices; economic growth; and fluctuations. Macroeconomic policies are explored in both closed and open economy models. ECON 3070 and 3080 may be taken in any order; there is no recommended sequence.

Prerequisites: i) ECON 1000 or 2020; and ii) either ECON 1078 and 1088, or MATH 1300, or MATH 1310, or MATH 1081, or MATH 1080, 1090, and 1100, or APPM 1350, or equivalent.

What I say: Where microeconomics focuses on individual markets, macroeconomics is a field that studies the economy as a whole. At this level, economists develop models to better understand the behavior of the aggregate economy in the long and short run. For the models that will be presented in this class, the main players are consumers, firms, and governments. My objective for the course is to teach you some of the models used by macroeconomists, as well as provide context so that you can discuss macroeconomics with others that are well versed in the tools, as well as those that are not.

The models covered in this course require a knowledge of calculus and algebra. Some common tools will be discussed very briefly in the first week of class, but there will be no formal review of the necessary mathematics. It will be assumed that those who remain enrolled in the class after the first week possess the necessary mathematics background.

### Exams

As we move through the course, concepts from later chapters will build on those learned in prior chapters. With this caveat in mind, the first two exams will not be cumulative. The final exam will be cumulative, though emphasis will be placed on concepts covered after the second exam. There will be no opportunity to make up missed exams. Missed exams will receive a grade of zero. If one midterm is missed due to a valid, excused emergency, your exam grade will be a weighted average of your other midterm and final grade. Please let me know within the first two weeks of the semester if you anticipate any scheduling conflicts.

Exams will require basic calculation. No graphing calculators or cell phone calculators will be allowed during exams. Basic, four-function calculators will be allowed. If you have a question about your calculator, please ask me before exam day. A basic rule of thumb: if it cost more than \$10 new, it probably isn't allowed.

# Problem sets

There will be four problem sets due over the course of the semester. Late assignments will not be accepted. Hard copies of these assignments are due at the beginning of class on the listed due date. These problem sets are a tool to help you prepare for the exams. Though each individual is required to turn in their own copy of the problem set, I strongly encourage you to work on these assignments in small groups.

## Paper

The paper is a capstone project for the course. I am looking for something no more than a few pages in length that is an exploration of a macroeconomic topic of interest to you. As mentioned previously, the course will provide an understanding of the tools of macroeconomics; this paper is an opportunity to apply these tools. A more detailed description of the assignment and grading rubric will be discussed in the later portion of the semester. I encourage you to discuss possible topics with me at any time during the semester.
