Course Overview

This course studies macroeconomic theories. We will investigate how an overall economy grows in the long run, and what determines the short run economic fluctuations. Also we study the collective behaviors of consumptions, investments, and government spending. Throughout the course we will seek to understand important theoretical models of macroeconomics. Specific topics include GDP, labor and capital markets, inflation, and the Great Recession and so on.

Textbook

Charles I. Jones (2011), Macroeconomics, 2nd edition, W.W. Norton & Company.

The first edition is okay to use.

Prerequisites

Economics prerequisites: ECON 2020 or ECON 1000

Math prerequisites: ECON 1078 & 1088 or MATH 1300 or MATH 1310 or MATH 1081 or MATH 1080 & 1900 & 1100 or APPM 1350 or equivalent.

This class covers the models that require algebra and basic calculus and every student is assumed to have a working knowledge of them. As such, the mathematics prerequisites will be enforced. There will be no separate math reviews.

Grading

There will be two midterm exams, a final exam, in-class assignments, and in-class Clicker questions. The grade of the student will be determined as:

25 % First Midterm

25 % Second Midterm

30 % Final

8% In-class assignments

7% Clicker questions

5% Attendance.

Concerning in-class assignments: Short problem-solving assignments will be given in class randomly throughout the semester and I expect you to be ready for them. You will form small groups to discuss and solve the problems in the assignment, but every individual should turn in his/her own copy. There will be several assignments and the lowest one will be dropped in calculation of your total score for all in-class assignments.

Concerning Clicker questions: A correct answer will receive 1 point and absences or incorrect answers will receive 0 point. In calculating your total score for all Clicker questions, I will sum your scores for all days, omitting your three lowest daily scores.

Concerning attendance: Attendance will be taken daily via either Clickers or the collection of in-class assignments. Therefore it is important that you answer all Clicker questions and submit your in-class assignments. You need to attend more than 80% of class meetings to get a passing grade, which means you will fail this course if you miss 10 or more of the scheduled class meetings. Leaving before a class session ends is considered as an absence.
