Course Description

This course covers economic concepts relating to the international economy and important developments in the global economy. The economic theory emphasized in the class will give students a better understanding of the foundations for international trade. Understanding this material will allow students to relate the importance of trade to political and cultural relations. In this course we undertake an in-depth study of the theories, policies, and institutions of international trade and finance. We have three basic objectives.

- The first is to build an analytical framework within which we can develop a logical approach to investigating international economics. The idea is for us to "think like economists," an approach that gives students both a sound basis for understanding the complexities of international commerce and the objectivity needed for assessing various policy proposals. An emphasis will be made on the assumptions underlying common trade models, and you will be expected to think critically about these assumptions and the models over all.
- The second goal is to gain a fuller appreciation of the complicated economic interrelationships that link nations and peoples. For example, why might the economies of the European Union and Japan continue to stagnate? These are complex issues without easy answers, but the goal is to establish a coherent, consistent, and realistic framework for thinking about them.

• The final objective is to apply the economics of trade to the world surrounding us. For example, it is not enough just to know how trade barriers work. We should investigate also why such policies exist and how costly or beneficial they are.

• Lectures

Lectures in this course consist mainly of explanation of concepts and sometimes problem solving and discussion. For more detailed schedule, **refer to the tentative course outline on the last page of this syllabus.** During the lecture, Clicker questions will be provided as a form of quiz so that you can self-check whether you are following or not. Your score for the Clicker questions will be added up to your final score as extra credits at the end of the semester.

• Exams (Midterms 20% each, Final 30%)

All exams (midterms and final) will be held in our normal classroom. Midterms will only cover the chapters you have newly learned (not cumulative). Final will include all the material coverd in class (cumulative). All exams consist of multiple choice questions and short answer questions.

There will be NO early or make-up exams. If you have to miss any of the midterms for emergency reasons (i.e. a family or medical emergency), you MUST inform me before the exam and provide documented accommodation. Only then, I will shift the weight of the midterms to the final exam.

The final exam cannot be missed under any circumstances. In other words, you cannot pass this course without taking the final exam. If you have more than two finals on the same day, you can reschedule all exams after the first two. If the final exam of this course should be rescheduled, you must notify me of this no later than October 27th, Friday with a proof that you already have two or more exams before this course's final exam.

Cheating in any of the exams is unacceptable Any cheating instances will result in a grade of zero and a report to the Honor Code Council.

• Homework (15%)

There will be 5 homework assignments throughout the semester. You can make a group of maximum 4 students to do them. You are encouraged to discuss the problem sets with your classmates. The purpose of assigning the problem sets is to help you learn the materials. Each group should hand in one copy of your answers to TA. The due dates will be announced during class. Also, I will drop 2 lowest score of the assignments. Late submissions are not allowed. If you have to submit late, you need to let me know before the deadline. Then I can give you grades with 10% of penalty.

• Discussion (10%)

You will be given some related topics (i.e., real-world applications) and will be asked to work as a group to discuss them. You will also be asked to either fill out and submit a discussion sheet or share your group's conclusion with the class as a format of a short presentation. Grades will be given based on the participation. More details to be provided in class.

• Attendance (5%)

You **need iClicker app** to check your attendance in every class.

Four absences will be dropped at the end of the semester. This means you do not need to prove your absences up to 4 times during the semester and these will not affect your final grade. However, if you have to miss the class more than four times, then you have to bring me official documentation(s) to prove your absence. Only then your absence can be excused. Otherwise, your attendance grade will be deducted.
