#### General:

ECON 3818 is a one-semester course in statistics, and is required for Economics majors. This is a math class and we will study probability, random variables, probability distributions especially the normal distribution, and descriptive and inferential statistics including estimation and hypothesis testing. Emphasis is on both theory and application.

# **Textbook:**

Statistics for Economics: An Intuitive Approach, HarperCollins Publisher, 1991. This book is out of print but you can get it at the CU Bookstore or on various online market places.

# **Grading:**

Your total grade in this course will be determined by the following breakdown.

- Recitation (20% of Grade): See your recitation syllabus.
- 2 Midterms (25% each): We will have 2 midterms each worth 25% of your grade.
- Final (30% of Grade): The final will be cumulative.

#### Homework:

Due to the size of this class homework will not be collected, I will however give a detailed list of suggested homework problems that you should not only complete but also study the solutions carefully as these problems are representative of the kind of questions you can expect on the Midterms and Final.

### **Communication:**

Outside of class I will communicate with you via email but primarily through the "News" section in D2L so check it early and often.

## **Test Policy:**

There will be no makeup exams. If you miss a midterm the percentage of your final grade that the missed exam represents will be added to the final exam. For example if you miss the first

midterm the final will count as 55% of your grade rather than 30%. There is no make up policy for the final. If you miss the final you get a zero, no exceptions.

#### **Calculators:**

You will not be allowed to use graphing calculators on any of this class's exams. On exam days, if you try to use a graphing calculator you will be asked to put it away.
