Course Objectives

Economics 3818 is a one-semester course in statistics, required of economics majors. We will study basic probability and probability distributions, especially the normal distribution; and descriptive and inferential statistics. Emphasis is on both theory and applications. The course will use Microsoft Excel to analyze data.

Prerequisites

Course prerequisites are Economics 1000, or 2010 and 2020; and either Economics 1078 and 1088 or equivalent math courses. These prerequisites are strictly enforced. If you are listed as not meeting the course prerequisites, you must show me that you have indeed met them.

Grading

Your course grade will be determined by adding the points you received the two mid-term examinations, the final, the homework, and the class participation. Your course grade will be calculated as follows:

Important Note: Attendance will be taken daily and the participation will be based on your attendance. **If you miss 7 or more of the scheduled regular class meetings, you will automatically fail this course.** There are no exceptions to this rule, so you are totally responsible for all your missing classes. Examinations All exams will take place in the regular class room on the dates listed below.

You should consider these dates to be firm and put them in your schedule. If there is any change, it will be announced sufficiently in advance. There will be no make-up exam. Make-ups for any exam will be allowed under compelling circumstances. Any make-up exam will be taken prior to the actual exam date, so you are required to make prior arrangements before the exam date.

Each exam will be composed of multiple choice and short answer questions. You should bring your simple calculator to the exam. Exam questions will be based on material covered in lecture and the problem sets. I will distribute the mock exam before the test.

Note that if you have 3 or more final examinations on the same day, they can arrange to take the Last Exam scheduled that day at an alternate time. It is their responsibility to notify you no later than six weeks into the semester and they must provide proof that you are administering their 3rd, 4th, or 5th exam of the day.

Homework: Homework will be posted periodically on the CUlearn. There will be six problem sets but only the best five will be counted. The maximum score on each assignment will be 100 points. You could discuss homework questions with other students but you should turn it in with your own work. Due dates for each homework will be announced in advance and **no late assignment will be accepted**.

Participation: This will be based on your attendance and your participation during class.
