**Course Description**

Financial market is an important part of economic life. This course aims to introduce academic as well as practical implications of workings of financial markets and risks. Students will get familiar with some of the financial ideas, real-world examples, and basic implementation. Students must be willing to do assignments using computer programs.

**Grading Policy**

Your final letter grade will be based on a midterm, a final exam, and a few (to be determined) assignments. While no prior knowledge is assumed, assignments would use some computer programs (e.g., Python, R/Stata, Excel).

The midterm enters your grade with a weight of **30%**, and the final with another **30%**, where the final is not cumulative. Assignments enter with a weight of **30%**, and class participation/attendance will enter with **10%**.

All exams and evaluations will be done by me in an anonymized fashion; the results are not disputable. Letter grades may be curved in that I will shift the total scores by the same amount for everyone at the end of the semester, subject to the Econ department policy. Letter grades are final and irreversible.

While you are highly encouraged to get to know each other and collaborate on the assignments, do not give or take any unauthorized help during exams. Note that no makeup exam can be provided, unless there is a valid emergency. In particular, you must take final exams on the University scheduled date.
