### **Course Description**

Entrepreneurship is an important part of modern economy. This course aims to introduce academic as well as practical implications of entrepreneurship and entrepreneurial financing. Students will get familiar with private equity (e.g., venture capital) and some real-world start-up examples. Students must complete a group final project.

### **Grading Policy**

Your final letter grade will be based on a midterm, a final exam, a group project as well as a couple of assignments. You must be willing to get to know your classmates, sort into groups of (mostly) 2, put efforts on the project and be responsible to your teammates. A solo project will not be accepted.

The midterm enters your grade with a weight of **25%** and the final with another **25%**, where the final is not cumulative. The final group project (presentation + a report) enters with a weight of **30%**. A couple of assignments enter with a weight of **12%**. Active participation/attendance will enter with **8%**.

All exams and evaluations will be done by me in an anonymized fashion; the results are not disputable. Letter grades may be curved in that I will shift the total scores by the same amount for everyone at the end of the semester, subject to the Econ dept grading policy. Letter grades are final and irrevocable.

While you are encouraged to get to know each other and collaborate on the startup project, please do not give or take any unauthorized help during exams. Note that no makeup exams can be provided, unless there is a valid emergency. In particular, you must take the final exam on the University-scheduled date.
