Course Objectives: Sustained economic growth is a relatively recent economic phenomenon that came about due to the Industrial Revolution and as a result of which the standards of living improved dramatically in the Anglo-Saxon West since the 18<sup>th</sup> century. However, global inequality has also risen to unprecedented levels because other parts of the world still significantly lag the West in economic, social and political terms. In this class, we shall study the comparative development paths of Anglo-Saxon Europe and the Middle East. In doing so, we shall primarily focus on the five books required for the class.

The class is also intended to provide an insiders' perspective on the writing of a book (*War, Peace and Prosperity in the Name of God*) by studying the literature, history and ideas that inspired various components and the key ideas which led to the book.

Assignments and Grading:

The final grade for the class will be determined as follows:
