COURSE DESCRIPTION

Macroeconomics is concerned with the behavior of the economy as a whole. During the semester, you will be introduced to the main building blocks of modern macroeconomic theory. By the end of the course you will learn how to think as a macroeconomist: how to isolate the main forces behind market outcomes, how to measure them, how to assess the impact of monetary/fiscal policies and changes in the economic environment on macroeconomic aggregates in the short and long run.

PREREQUISITES

Students are required to have earned a grade of at least a C- in Principles of Microeconomics (ECON 2010) prior to taking this course. It is also recommended students are competent in basic algebraic concepts such as fractions, graphing, and solving basic linear equations.

COURSE STRUCTURE

This class will meet for lecture twice a week where I will introduce the core concepts of the course. Each student should have also enrolled in a smaller recitation class once a week with a TA for this course. In recitation TA's will review the material, help prepare you for the test, and give you an opportunity to ask more questions. As per CU's requirements this course will meet remotely for the first two weeks. After which recitation and lecture will meet in person unless otherwise specified.

REQUIRED MATERIALS

Students enrolled in this class will automatically receive access to **MindTap** which includes access to an eBook version of the text and all of the homework.

Textbook: N. Gregory Mankiw, *Principles of Macroeconomics*, 9th edition.

Inclusive Access: To keep the cost of your course materials as low as possible and access to those materials as convenient as possible, we have collaborated with the CU Book Store and the publisher to deliver those materials through a program called "Day 1 Digital Access", which will appear on your tuition and fee bill as "Day 1 Digital Access". Homework: Homework will be all online and will be assigned weekly through MindTap. Each week homework will be due on Sunday at 11:59pm. **No late homework assignments are accepted**, begin your assignments early in the week in case you have any problems. Your 2 lowest scores will be dropped.

<u>Midterm Exams</u>: There will be two multiple choice midterm exams administered in-person during lecture. Midterms are not cumulative by design; however, the material in this course naturally builds on previous material.

I will count only the best grade between Midterm I and Midterm II. Accordingly, no makeup Midterms will be given.

Final Exam: The Final is a comprehensive multiple choice exam that covers all the material taught in this course. **No makeup final exam will be given.** The only exceptions are covered by campus guidelines on absences due to religious observance (see below).

<u>Grade Curves</u>: I will curve final course grades so that the class average is *at least* an 80%. If necessary, exam grades will be curved up so that the course average on each test is a 75%. I will never curve grades down.

Overall Course Grade Evaluation: At the end of the term, you will receive a letter grade which includes +/-. After rounding to the nearest percentage, I will strictly adhere to the assignment of your letter grade based on your percentage grade in the class.

Out of fairness to the whole class all grades will be determined as per the policies listed here. No exception will be made for any individual unless there are extreme extenuating circumstances approved by the University. Further I cannot "bump" grades or give extra credit to any individuals.
