Purpose: The purpose of this class is to introduce both the intuition behind and applications of statistical methods used in the social sciences, including economics. For most of you, this class will be your first introduction to the study of statistics. It is necessary to have solid foundational skills in algebra and to keep up with the class lectures and assignments. Please note that while we will make use of the statistical tools in Excel, the class is primarily a statistics course and not a computer applications course.

Textbook: The Basic Practice of Statistics, 4th edition by David S. Moore (required)

Technical Requirements: We will utilize **Microsoft Excel** for this course. Excel is available in all campus computer labs, including the lab in the basement of the Economics building.

You must have a two variable graphing calculator that has functions for correlation, mean, standard deviation, and least squares regression line. **The TI-83 or TI-84 calculator is *strongly recommended*.** This calculator will be necessary for in-class exercises as well as for exams.
