Syllabus

Course Objectives:

This course will introduce students to major policy issues confronting the Colorado economy. The course is divided into three major policy issues: tax and fiscal policy issues; economic growth, infrastructure and the environment; and human resources. In each of the three sections of the course major issues are identified. For each issue resource materials are suggested, including: legislation, suggested readings, and important links. Specific essay topics are also suggested relating to that issue. Students should select one of these essay topics from each of the three sections of the course. Students may also propose their own essay topic as long as it relates to a specific issue confronting the Colorado economy.

Course requirements:

Students are required to write three essays, one for each of the three sections of the course. These essays should be between 10 and 15 typewritten pages, double spaced. They should include appropriate documentation including both a bibliography and footnotes or endnotes.

Students who have chosen to write essays on a specific issue will present summaries of their paper in class. The class presentation should focus on the position they have taken on the policy issue and defense of that position. Students should not plan to read their paper. They should plan on about 10 minutes for each presentation. They will be expected to discuss and defend the position they have taken on the issue with other class members.

Class attendance and participation are an important part of this course. Students can miss one class in each of the three sections of the course without penalty, additional absences will result in lower grades on that topic.

In addition to the suggested readings on the syllabus students should develop their own bibliography in writing these essays. Additional source materials can be found in the following suggested sources:
