ECON 3080-005 INTERMEDIATE MACROECONOMIC THEORY

Course description:

This is a course in macroeconomics, which investigates the effects of aggregate decisions made by consumers and firms. In this course we will discuss issues relating to both long-run economic growth and short-run business cycles, and the role government can have in affecting each.

Prerequisites:

ECON 1000 or 2020; and either ECON 1078 and 1088, or MATH 1300, or MATH 1310, or MATH 1081, or MATH 1080, 1090, and 1100, or APPM 1350, or equivalent. Students who fail to meet these prerequisites are generally discouraged to take this course; if you, in this case, insist on getting enrolled, talk to me during the first week of the semester.

Grading:

Two midterms and a number of quizzes will be given in class. Midterm dates are September 29 (Tuesday) and November 10 (Tuesday). I will randomly choose five quizzes to grade. Each of midterm 1, midterm 2 and graded quizzes accounts for 30% of your total score. The lowest of the three will be dropped. There is no make-up for midterms or quizzes. I reserve the right to curve the scores or give extra credits.

A compulsory and cumulative final exam scheduled on December 16 (Wednesday), 1:30-4pm, accounts for 40% of your total score. The final exam will be administered in the same classroom. I will generally not allow you to take the final exam on an earlier or later date. This means that you have to make sure you have no other exams during that time. If you have three or more final examinations on that day, please have a talk with me no later than the end of the sixth week of the semester. In this case, you are expected to provide evidence that you have three or more examinations to qualify for exceptions.

A letter grade will be assigned according to your total score.

In the case of your own illness or injury, confirmation from a physician, physician's assistant, a nurse-practitioner, or a nurse is required. Be advised that the Wardenburg Health Center cannot provide such verification unless they have provided treatment and the student authorizes release of information to the instructor. Further, barring extraordinary circumstances, the confirmation must be available to me prior to the missed course event.

With regard to family emergencies, you must provide verifiable documentation of the emergency. Unless the emergency is critical you should notify me in advance of your absence from the scheduled course event. In cases of critical emergencies, you must notify me within one week of your absence.

For university-approved curricular and extra-curricular activities, verifiable documentation is also required. The student should obtain from the unit or department sponsoring the activity a letter (or class absence form) indicating the anticipated absence(s). The letter must be presented to me at least one week prior to the first absence.

If you miss either of the two midterms due to the above reasons and have provided qualified documentation, the other midterm will automatically account for 60%. If what you miss is any of the graded quizzes, the remainder will automatically account for 30%.
