Course description and objectives. The main objective of this course is to equip you with the knowledge and tools necessary to conduct empirical research using basic econometrics. To that end we will:

- 1. summarize, review and extend the classical linear regression model
- 2. explore various sources of economic data
- 3. introduce you to the basic features of a data management and statistical software called Stata.

By the end of the semester you will be able to carry out an empirical project that addresses a relevant social or economic issue using regression analysis and real data.
