COURSE OVERVIEW

This course introduces a theoretical framework to model the behavior of individual decision makers such as consumers and firms. The techniques covered in this course will be essential for anyone intending to pursue further studies in economics as many fields such as industrial organization, international trade and labor economics are built on microeconomic foundations.

The course begins by introducing the concept of consumer preferences. Preferences drive the choices of every consumer; and taken together, these choices determine market demand. On the supply side, it is production technology that drives the behavior of firms; and determines firm and market supply. The way in which demand and supply interact to determine price and output depends upon the nature of competition in the market. In this course we will consider three market structures: perfect competition, monopoly and oligopoly.

PREREQUISITES

- 1. Economics prerequisites: ECON 1000 or 2010
- 2. Mathematics prerequisites: ECON 1078 & ECON 1088 or MATH 1300 or MATH 1310 or MATH 1081 or MATH 1080 & 1090 & 1100 or APPM 1350 or equivalent.

The material covered in this course requires basic calculus and high school algebra. It will be assumed that every student has a working knowledge of calculus. The mathematics prerequisites will be strictly enforced. Calculus courses taken in the same semester will not be sufficient.

COURSE STRUCTURE

There are three components to the course: lectures, assignments, and exams.

- 1. The lectures will follow the textbook in terms of topics covered. However, there may be some material covered in lecture that is not covered in the textbook.
- 2. Assignments will take the form of problem sets.
- 3. There will be two midterm exams and a final exam.

GRADING

Your course grade will be calculated as follows:

25% (Midterm 1) + 25% (Midterm 2) + 30% (Final) + 20% (Problem Sets)

LECTURES

Attendance will be taken daily and if you miss more than 20% (9 class meetings) of the scheduled class meetings your course grade will be automatically lowered two levels (e.g. if you get a B+ but have missed 9 or more classes, your grade will be lowered to a B-). These absences are intended to cover both valid (illness, car breaking down, family emergency) and invalid reasons

for missing class. If you miss the first three class meetings, you may be administratively dropped from the class. You are responsible for all information covered in class lectures. I do not post or give out my notes. If you miss a class, you should be able to get notes from one of your classmates. You can come to my office hours to discuss the material you missed, but you must first obtain the notes and relevant handouts, go over them and prepare specific questions.

PROBLEM SETS

Problem sets constitute 20% of your course grade. The schedule of when problem sets are due is given below. The problem sets must be handed in class the day they are due. I will announce in class when problem sets are posted. You will not receive credit for late assignments. You may miss one assignment, as your lowest problem set grade will be dropped (5 out of a total of 6 count towards your grade).

You are encouraged to work in groups but everyone must turn in their own copy of the problem sets. If you use more than one piece of paper, staple all your sheets together in order.

EXAMS

Each exam will have two sections: a multiple-choice section and a short answer section. You must bring a #2 pencil and a non-graphing/non-scientific/non-financial calculator to the exam (a ruler is also recommended). If you do not comply to the calculator standards, 5 points will be deducted from your grade on an exam.

Midterm exams will not be cumulative. Exam material will be based off of the lecture notes and problem sets. I will announce before each exam the topics that will be included.

Midterm 1 will take place on **Wednesday**, **September 29**th and midterm 2 will take place on **Wednesday**, **November 10**th. Midterm exams will be held in the usual classroom during lecture time. **The final exam will be cumulative** and will take place on **Tuesday**, **December 14**th from **1:30 pm to 4:00 pm**. It will be held in the usual classroom.

There will be **no extra credit opportunities**.

Note: If you have 3 or more final exams on the same day, you are entitled to arrange an alternative exam time for the **last** exam scheduled on that day. To qualify for rescheduling final exam times, you must provide evidence that you have 3 or more exams on the same day, and you must make arrangements no later than the 6th week of the semester (no later than Friday, October 1st, 2010).

MISSED ASSIGNMENTS AND EXAMS

Late assignments will not be accepted since solutions will be posted online after the assignment is due. There will be no makeup exams and early exams. Exam

absences will only be excused for compelling circumstances (generally family emergencies or documented illness), in which case the other exams will be reweighted.
