Course Description

The study of Economics is more than a college course; it is a way of thinking and interpreting the events occurring in the world around us. In this course, we will extend the concepts you learned in your introductory courses with graphical and analytical tools, as well as some intuition. The course begins with a detailed analysis of consumer theory as we discover how the demand side of the economy is built from the decisions of individuals. Then we will move to producer theory as we learn how a firm's production technology and cost structure provides the basis for the supply side of the economy. Finally, we will explore how these concepts apply to a number of different market structures, including perfect competition, monopoly, and various forms of imperfect competition. By the end of this course, you will have acquired the tools to advance further in the study of economics and to better understand the microeconomic foundations of the world around you.

Prerequisites

It is assumed that every student has a working knowledge of basic algebra, calculus and graphing skills. Relevant math techniques will be briefly reviewed when necessary, but you are responsible for the math requirements of this course.

Required Textbook/Materials

Microeconomics, by Besanko and Braeutigam, 4th Edition, Wiley (The 3rd edition also works). I recommended reviewing the previous days notes and reading the relevant chapters in the textbook before each lecture.

What Goes Into Your Grade

Homework

I will assign five problem sets to give you the opportunity to practice the material from lecture. These will be directly related to the material from the lecture and they will be designed to give you ample amounts of practice in completing the types of problems you will encounter on exams. Each homework will be worth 25 points, 5 points is based on completeness and the remaining 20 points come from a sample of randomly selected problems that make up about one-third of the total questions. Homework assignments will be posted on Desire2Learn 7-10 days before they are due. You will get to drop your lowest homework score.

Group Assignments and Participation

Forming a study group from the beginning is one of the most effective ways to master the material and study for exams. Therefore, we will be forming teams and working on in-class assignments in these groups several times throughout the semester. The in-class assignments will feature one or two questions and will be graded on a 0 to 5 scale. At the beginning of the next class teams can volunteer to demonstrate one of the problems from the previous days in-class assignment for an extra point. Attendance is required to receive credit for in-class assignments and you will receive a grade of zero if you are not present in class to participate in the team assignment. There will be no way to make-up team assignments if you miss them.

Midterm Exams

There will be two midterm exams during the semester. The first midterm is scheduled for Friday Oct 5th, the second midterm is on Wednesday Nov 14th . I will not give any early exams or make up exams and no exams will be dropped. The only exception is for student athletes with scheduled events on the date of the exams. Please check into this immediately and let me know as soon as possible. I require a signed letter from your coach or the athletics department.

The format of the exams will have multiple choice and short answer questions. Please bring a #2 pencil and a calculator to every exam. Midterm exams will not be cumulative, but the material builds upon itself, so it is important to understand each concept along the way. Any material covered in lecture and/or in the assigned readings is fair game for the exams.

Final Exam

The final exam is scheduled for Dec 15th from 7:30 pm to 10 pm. The final will be cumulative.

If you have an 95% or higher in the course going into the Final Exam you will not be required to take the final exam and you will receive an A in the course.

Attendance

I will be taking attendance at random six times throughout the semester. You are allowed to have three absences without consequence. For each additional absence (4 or more) I'll deduct 3% from your final grade in the course. For example, if you are absent five of the six times I take attendance your maximum possible grade is a 94%. Individuals that are present all six times get a 3% bonus on your final grade in the course.

Late Work Policy

You are welcome to make up any homework late but each day the assignment is late it reduces the potential score by 20%.

Calculators

Neither graphing calculators nor cell phone calculators will be allowed during exams!!!

Do not ask me to use either type on an exam; I will not make an exception and the answer will be a definitive "No." Please be sure to obtain an acceptable calculator type (any type of calculator other than a graphing calculator or cell phone calculator) to use for exams.
