Course Description

Principles of Microeconomics is an introductory course aimed at introducing students to major economic concepts; including but not limited to scarcity, supply and demand, markets, trade, specialization, market failures, and government intervention. While applications of these topics will be discussed, the majority of the class will focus on establishing an understanding of basic theory.

Text

We will use Principles of Microeconomics by N. Gregory Mankiw, 8th edition. Please note that this is an "inclusive access" course. What this means is that you have electronic access to your course materials immediately through Desire2Learn (D2L) if you are enrolled in the course. You do not need to go to the bookstore. You do not need to pay for them right now. Should you drop the course, you will not be billed for the materials. If you stay in the course, the CU Book Store will bill you for these materials on your tuition and fee bill at the guaranteed lowest price. This charge will occur at or near the drop/add date. The charge for these materials before tax will be: \$92.51. Although this is required course material, federal law mandates that you have the option of declining these materials. Please keep in mind that "opting out" means that your access to these materials will be turned off and you will have no way to complete assignments.

Clickers

You will also need an i>clicker. You can purchase it at the CU Bookstore, if you do not have one already. We will use clickers regularly to review examples and to solve problems, beginning the

second week of class. You will receive one point for participating in each clicker question. Your lowest three clicker grades for the semester will be dropped. Please note that it is considered cheating to bring a classmate's clicker to class. If you are caught with more than one clicker, you will be asked to leave class for the day and you and the classmate(s) whose clicker you have will receive a 0 for the semester clicker grade.

Please make sure to register your clicker at https://cuconnect.colorado.edu/uPortal/index.jsp. Failure to register your clicker will result in a score of zero for all clicker questions.

Midterms

There will be 3 multiple choice midterms. Each midterm will be worth 20%. The lowest midterm score will be dropped when calculating class grades. Student or government issued IDs must be taken to all the midterms. Students who enter their ID number incorrectly on the exam will lose 5 percentage points. Your lowest midterm score will be replaced with your recitation grade (if your recitation grade is higher). <u>THERE WILL BE NO MAKE-UP EXAMS.</u> If you cannot take an exam because of an emergency or other commitment, you can drop the zero and replace it with your recitation grade. Your recitation grade CANNOT replace the final exam.

Recitation

Recitation begins the second week of classes. Recitation grades will be based on a combination of attendance and homework. Leaving early will result in no credit for the day unless there was prior approval by the TA. Arriving between 5 and 10 minutes late will result in half credit for the day and arriving after 10 minutes late will result in no credit for the day. Homework will be done on MindTap, and will generally be due every Sunday at 11:59 PM. I will try to announce whenever homework is due at a different time, but it is your responsibility to check online. To access the homework, go to the course D2L page, go to the table of contents, choose "MindTap Resources", and then click "MindTap and ebook access." Working with others is allowed. No late work will be accepted. The lowest homework score will be dropped. There is no makeup policy. Specific questions about the homework should be addressed to your TA.
